**Supplement to Beyond Nuclear et al Emergency Enforcement Petition  
(10 CFR 2.206) re: Creusot Forge and request for Official Proceedings  
Transcript to include a complete list of industry and other public  
stakeholders attending the March 8, 2017 Petition Review Board meeting**

Ms. Banic:

I am supplementing our January 24, 2017 emergency enforcement petition (10 CFR 2.206) with a request regarding the Areva-Creusot Forge at-risk components in U.S. power reactors and the Nuclear Regulatory Commission (NRC) Official Transcript of Proceeding of the March 8, 2017 Petition Review Board (PRB) meeting with the Petitioners.

As provided by email to you as our Petition Manager, on behalf of co-petitioners Beyond Nuclear is requesting that the NRC make public the complete list of those who were in attendance to the PRB meeting.

The Official Transcript of Proceeding (ML17081A418)<sup>1</sup> reflects that additional attendees were present both in the conference room at NRC Headquarters and on the telephone bridge line that are not identified as part of this proceeding. The transcript additionally identifies that the Court Reporter's audio of the proceeding was interrupted in the beginning when those introductions in the conference room were made. Additionally, there were numerous licensees on the telephone bridge line who were asked by the Chair to identify themselves by email to the PRB.

*MR. RICHARDS: This is Mark Richards, Nuclear Energy Institute. I do have one question not related to process, but referring to the Large Associates report that I believe Mr. Gunter referred to. Is that publicly available?*

*MR. GUNTER: Yes, it is publicly available and it is linked with -- on -- through the petition itself. The January 24, 2017 petition has a footnote with the hyperlink.*

*Mr. Richards: Okay. Thank you.<sup>3</sup>*

The NEI representative is otherwise not identified or listed as an attendee in the NRC transcript.

[At pages 51-52]

*COURT REPORTER: Hi, this is the court reporter. I just wanted to mention that in the beginning about a minute in I did lose -- I dropped out of the call somehow, so there were a few minutes that I did not get. So I think you all said that you're recording this.*

*MS. Brown: Yes.*

*COURT REPORTER: Okay. So if I could somehow have access to that -- I don't know if this is the right time to mention it, but --*

*MS. BROWN: Absolutely. Merrilee will make sure that you get a copy of that.*

*COURT REPORTER: Oh, okay. Thank you. Other than that I don't need anything else. Thank you.<sup>4</sup>*

Beyond Nuclear is therefore asking on behalf of the co-petitioners that a complete list of all attendees (in the NRC conference room and on the telephone bridge line) be made public as part of the PRB proceeding record.
