Revision of Fee Schedules: Fee Recovery for Fiscal Year 2017; Final Rule; Parts 170 and 171 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ73; NRC-2016-0081)

On June 30, 2017, the NRC published a final rule in the *Federal Register* ([82 FR 30682](#)) amending the licensing, inspection, special project, and annual fees charged to its applicants and licensees. These amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990 as amended, which requires the NRC to recover approximately 90 percent of its annual budget through fees. This final rule is effective August 29, 2017.
