#### Incorporation by Reference of American Society of Mechanical Engineers Codes and Code Cases; Final Rule; Part 50 of Title 10 of the Code of Federal Regulations (10 CFR) (Regulation Identifier Number (RIN) 3150-AI97; NRC-2011-0088)

On July 18, 2017, the NRC published a final rule in the *Federal Register* (82 FR 32934) amending its regulations to incorporate by reference recent editions and addenda to the American Society of Mechanical Engineers (ASME) Codes for nuclear power plants and a standard for quality assurance. The NRC is also incorporating by reference six ASME Code Cases. This action is in accordance with the NRC's policy to periodically update the regulations to incorporate by reference new editions and addenda of the ASME Codes, and is intended to maintain the safety of nuclear power plants and to make NRC activities more effective and efficient. The final rule is effective on August 17, 2017.

#### <u>Revision of Fee Schedules; Fee Recovery for Fiscal Year 2017; Final Rule; Correction;</u> <u>10 CFR Part 170 (RIN 3150-AJ73; NRC Docket ID NRC-2016-0081)</u>

On July 19, 2017, the NRC published a document in the *Federal Register* (<u>82 FR 33000</u>) that corrects the annual fees for fuel facility licensees in a final rule published in the *Federal Register* on June 30, 2017 (<u>82 FR 30682</u>). The final rule, once effective, will amend the licensing, inspection, special project, and annual fees charged to NRC applicants and licensees and will be effective as of August 29, 2017. The corrections also are effective as of August 29, 2017.
