Office of the Chief Information Officer-Information and Records Management Policy and Compliance

On August 7, 2017, contract number NRC-HQ-10-17-C-0001 was awarded to BarnAllen Technologies, Inc., Rockville, Maryland. The objective of this contract is to obtain support for Office of the Chief Information Officer (OCIO) in providing information and records management policy and compliance. These tasks include completing the development and revision of records retention schedules in order to obtain the National Archives and Records Administration's approval, updating/validating office file plans, developing and publishing a subject taxonomy, and coordinating with other agency staff as needed, on the development of standard procedures for adding documents to records repositories such as the U.S. Nuclear Regulatory Commission's (NRC's) Agencywide Documents Access and Management System and Microsoft SharePoint, and incorporating those procedures in desk guides, templates, and instructions. The period of performance for this contract is from July 31, 2017, to July 30, 2018, with four 1-year option periods. The total potential value over the life of the contract is \$905,256.24.
