Low-Level Radioactive Waste Disposal; Regulatory Analysis; Reopening of Comment Period; Part 61 of Title 10 of the Code of Federal Regulations (Regulatory Identifier Number 3150-Al92; NRC-2011-0012)

On November 24, 2017, the NRC published a Federal Register Notice (FRN) in the *Federal Register* (82 FR 55790) reopening the comment period for an FRN that was published in the *Federal Register* on October 17, 2017, "Draft Regulatory Analysis for Final Rule: Low-Level Radioactive Waste Disposal" (82 FR 48283). The public comment period that closed on November 16, 2017, has been reopened to allow more time for members of the public to develop and submit their comments. The comment period for the *Federal Register* document published on October 17, 2017, is reopened and now closes on December 18, 2017.
