Revised Technical Specifications

By letter dated February 7, 1990, as supplemented April 24, 1990, FPL applied for license amendments which modified the Unit 3 and Unit 4 Technical Specifications pertaining to the Company Nuclear Review Board (CNRB). By letter dated July 3, 1990, the NRC issued Amendments 136 and 131 to Facility Operating Licenses DPR-31 and DPR-41. These Amendments change Technical Specification (TS) 6.5.2.2 by removing the specific composition list for the CNRB, and revise TS 6.5.2.6 to redefine a quorum of the CNRB.

The changes included in Amendments 136 and 131 supersede those which are included in our proposed Amendment to replace the current Technical Specifications dated June 5, 1989 (FPL Letter No. L-89-201). Accordingly, we withdraw the proposed changes concerning the CNRB identified in our June 5, 1989 letter. The revised Technical Specifications should reflect the changes approved in Amendments 136 and 131.
