The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2017-007) on January 13, 2017, to determine if a former contract recovery team employee had been discriminated against for raising safety concerns. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the former contract recovery team employee had been discriminated against for raising safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
