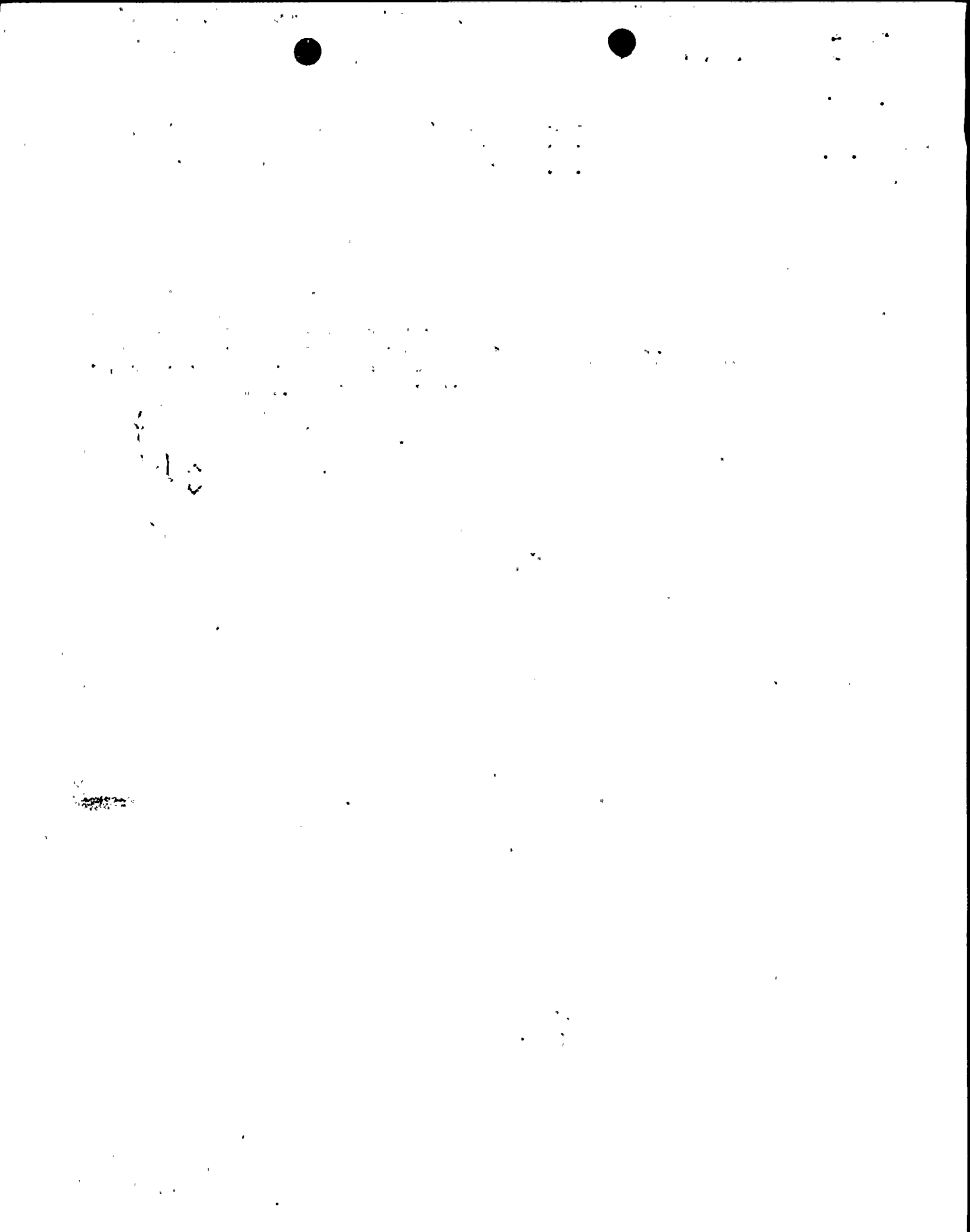

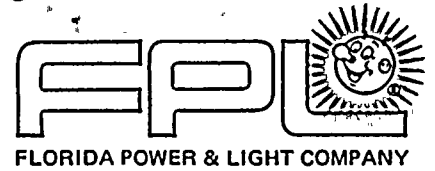

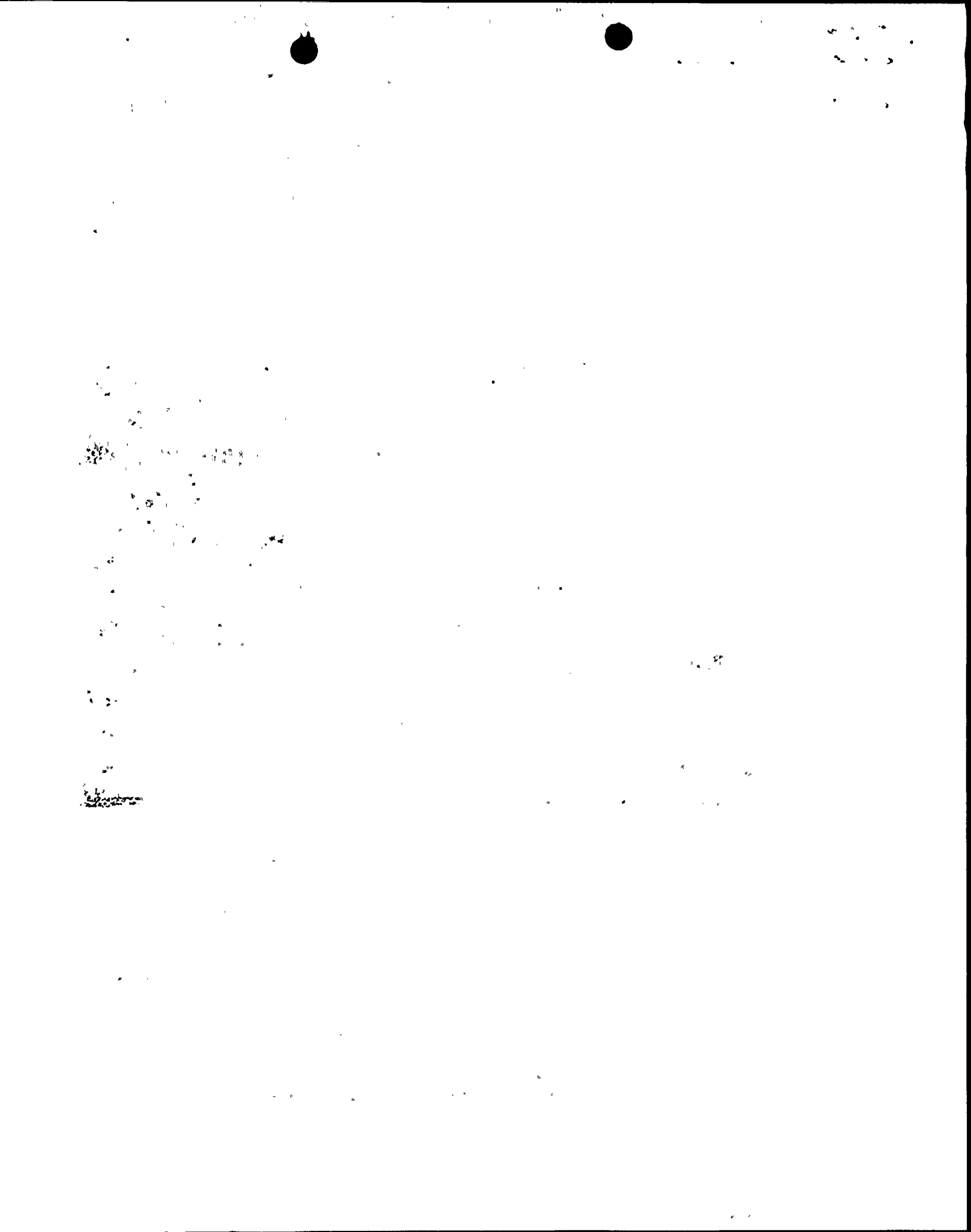

DETAILS OF CONFERENCE:

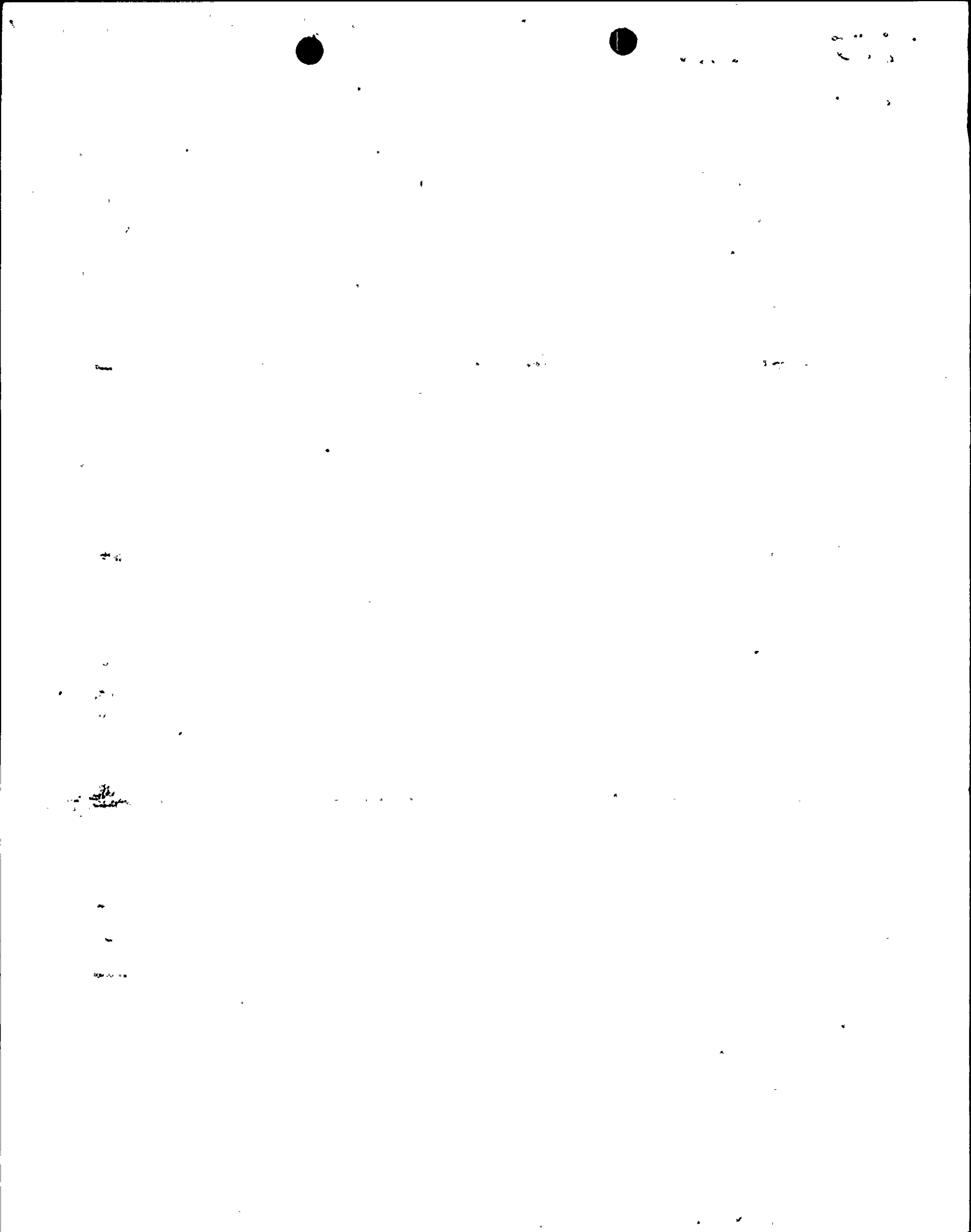
Mr. Harris notified Mr. Lewis that a leak has appeared in a fillet weld on line 1-SI-228 on Safety Injection Header 1A2 in containment. The unit was placed in a cold shutdown condition as this is considered Pressure Boundary Leakage and is being reported under Reg. Guide 1.16 Section 2.a.3 as prompt reportable. This leak appears to be the same type of problem that occurred in 1975 during Hot Functional testing. F&L Engineering is evaluating the leak and line restraints for this header. The three other SI Headers have the same type of drain line restraints and are also being evaluated.

DETAILS OF CONFERENCE:

Mr. Harris notified Mr. Lewis that a leak has appeared in a fillet weld in line 1"-SI-228 on Safety Injection Header 1A2 in containment. The unit was placed in a cold shutdown condition as this is considered Pressure Boundary Leakage and is being reported under Reg. Guide 1.16 Section 2.a.3 as prompt reportable. This leak appears to be the same type of problem that occurred in 1975 during hot functional testing. F&L Engineering is evaluating the leak and line restraints for this header. The three other SI Headers have the same type of drain line restraints and are also being evaluated.
