# Sununu Would Support Smaller Seabrook Zone

CONCORD (UPI) — Gov. John Sununu, breaking ranks with New Hampshire's congressional delegation, said yesterday he would support a smaller evacuation zone for the Seabrook nuclear power plant if approved by federal regulators.

Sununu, who has supported the existing federally required 10-mile zone for Seabrook, said he would defer to the Nuclear Regulatory Commission if the federal agency decides a smaller zone is appropriate.

"I prefer that it be kept at the 10-mile zone, but I recognize that the NRC has both the authority and a responsibility to determine what should take place within that region," said Sununu, a Republican who has supported Seabrook and was re-elected last month to a third term.

New Hampshire's all-Republican congressional delegation, however, last week said it supports keeping the zone at 10 miles and opposed any move to compromise emergency plans.

Asked whether his support of a smaller zone would create a perception of a rift between Republicans, Sununu said he did not know. He said the stand taken by delegation members was "their decision."

Seabrook management has

been considering whether to ask the NRC to authorize a smaller zone. Management is expected to file an official request to the NRC later this month involving evacuation regulations.

Approval of the evacuation plans is required before the estimated \$5 billion plant can receive an operating license. But Massachusetts Gov. Michael Dukakis, citing safety concerns, has refused to submit plans for the six communities in his state within 10 miles of Seabrook.

Reducing the evacuation zone from 10 miles to 1 mile or 2 miles would reduce the role Massachusetts plays in the evacuation process and remove a major stumbling block in Seabrook management's request for an operating license. The project is already seven years behind schedule.

"If the NRC finds that it is in the best interest of everyone involved, and assures the safety of the public that a smaller zone is appropriate, I defer to the NRC," Sununu said in an interview with United Press International.

"The NRC has both the authority and the responsibility to make that decision. And they're going to make that on the basis of what is technically and practically the most appro-

appropriate distance to have," Sununu said.

Providing Seabrook management requests a change, Sununu said he expected the NRC probably would "put it in the context of a graded response," which would involve different degrees of emergency plans in different distances from the plant.

"If an evacuation is not necessary for public safety, then it is not in the public interest to require an evacuation," Sununu added. "Because every time you evacuate, just the transportation and the automobile travel and so on under an evacuation condition puts the public at risk."

"If they would be safer by not being evacuated, I think it is ludicrous for anybody to ask for a public policy to ask for unnecessary evacuation," he said.

Sununu acknowledged that his support of smaller zone would be a change in his previous stand, but said his support of a "graded" response plan has been consistent.

He also said there should be no political pressure put on the NRC.

"To suggest that the NRC ought to be pressured politically one way or the other to change its conclusion, is inappropriate," Sununu said.

## Sununu: Nuke puppet

NEW Hampshire Governor John Sununu, who was appointed as Bush's Chief of Staff, is a tool of the nuclear industry. Executives for Westinghouse, the company which built Seabrook Station, contributed heavily to Sununu's campaign expenses. Stone and Webster, designers of nuclear plants, General Electric Company, and Babcock and Wilcox, builders of Three Mile Island, all gave Sununu money. Nuclear utilities, including Duke Power and Light of North Carolina, Southern California Edison, and Northeast Utilities have also donated to Sununu. Everyone from the governor of Massachusetts to Seabrook fishermen knows evacuation is impossible but Sununu's concern is not for public safety; rather, it is for nuclear profit.

Sununu's policy is illustrated by the recent executive order signed by President Reagan, which circumvents the law giving states the right to decide whether populations around nuclear plants can be evacuated during a nuclear accident.

Just as Sununu has been willing to ignore his responsibilities to the public as governor of New Hampshire, so he will remain the nuclear industry's errand boy while in the White House.

In choosing a Chief of Staff, there should be two basic

requirements: peripheral vision and foresight. Sununu has not shown he has either on the nuclear issue. Sununu refers to himself as a "pussy cat." He had better tread more carefully than he has as New Hampshire governor because either the people of this country or Sununu's own twisted priorities will force Bush to put the cat out.

I believe that some action should be taken to obtain an unequivocal written or public statement from Chairman Selin supporting the specific provisions of S.1220 as the bill itself before the Senate floor. Read below several options for doing that and have summarized what pros and cons.

Option 1: Seek Chairman Selin's Signature on a Joint Statement With Admiral Watkins in Support of the Provisions of S.1220. (A draft such statement is attached for consideration.) Seek Governor Sununu's Action on Unresolved Issues.

Pros: Can be used as written evidence with Senators and Congressmen to show joint support and undo oral statements by Chairman Selin.  
Can be negotiated with him in advance, before his interaction with Admiral Watkins, to minimize differences to resolve.  
If differences cannot be resolved, would at least minimize issues needing action by Governor Sununu.

Cons: May be impossible to reach agreement with Chairman Selin on such a statement, or may take too much time and argument.  
Has potential appearance that DOE has forced NRC to support S.1220.

Option 2: Prepare a White Paper on DOE and NRC Support of the Provisions of S.1220. Have Governor Sununu Seek Chairman Selin's Agreement with the White Paper. (The White Paper would be like the attached statement, with the joint signature concept removed.)

\* Pros: Chairman Selin might more quickly fall in line for Governor Sununu than he would for Admiral Watkins.  
Would most quickly show Governor Sununu what the problems with Chairman Selin are.

Would still provide a written statement for use with the Congress, although not signed.

Cons: Does not minimize the issues that Governor Sununu may have to resolve.

Option 3: Have Senator Johnston Hold a Hearing to Obtain Chairman Selin's Agreement with the Provisions of S.1220. Show Senator Johnston Our White Paper from which to Frame Questions. Have Governor Sununu Speak to Chairman Selin in Advance.

Pros: Chairman Selin may be more responsive to Senator Johnston than to the Administration.—Transcript could be edited for Senate floor use.

\* Cons: What Chairman Selin might say in public is very unpredictable.

In May, 1983, my father-in-law, Admiral Hyman G. Rickover, told me that at the time of the Three Mile Island nuclear reactor accident, a full report was commissioned by President Jimmy Carter. He (my father-in-law) said that the report, if published in its entirety, would have destroyed the civilian nuclear power industry, because the accident at Three Mile Island was infinitely more dangerous than was ever made public. He told me that he had used his enormous personal influence with President Carter to persuade him to publish the report only in a highly "diluted" form. The President himself had originally wished the full report to be made public.

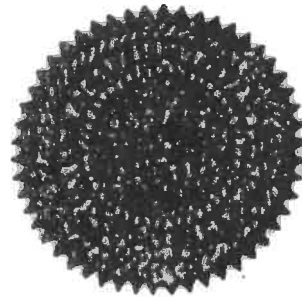
In November, 1985, my father-in-law told me that he had come to deeply regret his action in persuading President Carter to suppress the most alarming aspects of that report.

Mr. Barkley,

You asked me to wait until June 29, 2018, for you to respond to We The People's and my responses I sent you concerning Mr. Bower's letter to WTP of May 10, 2018. As you know, in a reply back to you in a previous e-mail, I said I would as you are very busy doing an extensive inspection at the Susquehanna Nuclear Plant till 6/28.

I was willing, until I read what NRC spokesman, Neil Sheehan, in his comments published in the Hampton Union Article (see below) of June 22, 2018, entitled " Selectmen call for NRC hearing on nuke plant evacuation". We The People (WTP) believes and knows, Mr. Sheehan, is not making accurate statements to the public about all of the information FEMA and NRC know about what you provided them from information WTP informed you regarding troubling information connected to Seabrook Station Evacuation Plan. In all due respect to Mr. Sheehan, he is misleading the public about the Seabrook Station's Evacuation Plan. The only real way for everyone to know whether the Seabrook Nuclear Plant's Evacuation Plan can be implemented in a safe and timely way in the event of a nuclear disaster is if and when the NRC and FEMA, together, endorse WTP's call for this First Responders' Hearing. As FEMA, NRC and their Spokesman, Mr. Sheehan, know, 7 MA Cities/Towns, and, now the NH Town of Hampton Falls, are calling for this Hearing. You can count on WTP bringing to the rest of the NH Cities/Towns within the 10 mile radius of the plant the real truths of the unsafe conditions at Seabrook Nuclear Plant, and their Evacuation Plan, which cannot be effectively implemented, especially during the summer months.

Why doesn't Mr. Sheehan admit the NRC, FEMA, MEMA, MA Governor Baker, MA Attorney General, Maura Healey, MA Secretary of Public Safety, Daniel Bennett, NH Governor Sununu, NH Attorney General, Gordon MacDonald, have not acted on, and, in-fact, are impeding an investigation from evidence We The People has provided them pertaining to Seabrook's Evacuation Plan? Both FEMA and NRC have known this information for some time now which also includes information concerning the present GAG ORDERS on the MA State Police and the NH National Guard. My own contacts within the NRC and FEMA have stated to me, Officials at MEMA and at the MA Secretary of Public Safety should have and had a responsibility to report this information to FEMA and to the NRC. **The NRC and FEMA, for failing to call for this and other investigations, are now, also, participants in impeding these probes which is an Obstruction of Justice in the eyes of many including WTP.**

These attempts to silence First Responders from making comments about their own opinions on the effectiveness of the Seabrook Nuclear Plant's Evacuation Plan need to be, **finally, fully investigated, along with holding those accountable who were, and who are still implementing these GAG ORDERS.** In addition, the NRC and FEMA have a responsibility to call for a probe of why all the agencies and high officials, mentioned above, have not called for an investigation of what was said, and the documentation provided by WTP, at the Meeting to which I was asked to attend by Francis Hughes, former MA State Police Deputy Commander, September 2, 2016, at the MA State Police Barracks in Newbury, MA. **As you, and other officials at the NRC, FEMA, MEMA, MDPS and Representative Elijah Cummings, Ranking Member of the Committee on Oversight and Government Reform know, I am willing, and can, recall everything that occurred at this meeting 9-2-2016 , only if I am placed under oath so everything can and will be made a public record.**

Mr. Barkley, in connection with President Trump's Administration's obvious mission, at all costs, including safety of those who live on the MA and NH Seacoast and beyond, to extend Seabrook Station's Operating License from 2030 to 2050, you must be now echoing some of the same words which I read in Bill Dedman's article of March 10, 2014, entitled "U.S. Nuclear Agency Hid Concerns, Hailed Safety Record as Fukushima Melted.." Unlike Bill Dedman, who refuses to violate the words in the Journalist's Creed "The suppression of the news , for any consideration other than the welfare of society; is a betrayal of the public trust and is indefensible". Mr. Dedman demonstrated, in his article, he was not willing to be intimidated by the powerful Nuclear Industry and the Washington Establishment like most of the National Media, and especially some of the so-called journalists, who, in NH, remain on Lockdown due to John Sununu's influence. They will not write about WTP's evidence of NRC Cover-ups of unsafe conditions at most, if not all, U.S. Nuclear Plants including Seabrook Station. Bill Dedman, who refused to violate the Journalist Creed by suppressing cover-ups by the NRC, instead quoted the following about you, "NRC Engineer Richard Barkley pointed out that the NRC Staff that week to recommend extending for 20 years the license for reactors a nuclear power plant in New England called Vermont Yankee. He warned colleagues, 'That was a very scary picture to myself, much less the public, especially since the machine is a GE designed BWR (boiled-water reactor) not radically different in size, age and design than some high visibility plants in

my region. I can see the cards and letters coming to my in-box by Monday.' Ultimately, the NRC delayed the Vermont Yankee re-licensing only briefly, approving it on March 21, 2014.)" Then Bill Dedman went on to say, " Three decades after the partial meltdown at the Three Mile Island nuclear plant in Pennsylvania, nuclear power companies saw hope for a renaissance, with the first new reactors in years being planned. but public opinion was fragile: If the Fukushima reactor, built by American companies, could be overwhelmed by natural disaster, could the public trust that American power plants were safe?"

We The People, and I, cannot and will not wait any longer for President Trump's Appointee of Nuclear Regulatory Commission Chairwoman, Kristine L. Svinicki , to honor WTP's and my request for her to meet with me and address the many comments and questions I posed through you in hoping for her to act on, and resolve. I would like you to notify Kristine L. Svinicki that We The People is officially requesting her to resign and step down as Chairwoman of the Nuclear Regulatory Commission for Jeopardizing the safety of citizens and their families who live in MA, NH and beyond. WTP's informants and I were hoping, during Chair Svinicki's watch, that she would help us prevent a nuclear disaster rather than wait and react to one, which is what the NRC, FEMA and other officials in MA, NH, and the Washington establishment, including the press are currently doing. From what WTP and I know and have been given from Past and Present employees within the Nuclear Industries, and at the NRC, we can have a nuclear disaster in the U.S. any day because of the way these American's nuclear plants have been built, and are presently being operated, with Counterfeit Substandard Parts.

The following comments are my responses and questions to Mr. Fred Bower's letter of May10, 2018 with enclosures to We The People.

**Mr. Bower Stated in the Second Paragraph of his letter to me of My 10, 2018 the following:** "in response to your request for copies of the notes taken at a September 2, 2016, meeting with Deputy Massachusetts State Police Commander Francis Hughes between you, the Commander, and John Giarrusso of the Massachusetts Emergency Management Agency (MEMA), we suggest that you direct you request to one of these parties or make a public records request to the State of Massachusetts via [www.Mass.gov](http://www.Mass.gov). The NRC was not present at that meeting and thus does not have notes of what was discussed."

**Comley response:** The NRC is already aware from my messages to you and my letter of March 16, 2018 (**attached**) and Trooper Cristina J. Lucin's letter of February 14, 2018 (**attached**) which confirm I know notes were taken at the meeting 9-2-16 **which now are being reported as missing or were destroyed.** Due to these circumstances, what is the point of WTP making a Public Records Request to the State of Massachusetts via [www.Mass.gov](http://www.Mass.gov) ? **Please reply.** WTP does see plenty of justification for the NRC and FEMA to fully investigate what are the recollections by Nuclear Section Chief of MEMA, John Giarrusso and Former Deputy Francis Hughes who also were in attendance at this meeting 9-2-14. Surely both of these officials would be able to recall some of what I said and provided at this meeting, especially since I included the identities of WTP's informants connected to the present GAG ORDERS on the MA State Police and the NH National Guard. **I am certainly willing to provide my complete recollection of what I provided and what others and I said at the Meeting of 9-2-16 as long as**

**I am placed under oath so everything becomes a public record.** Given these notes and information are having to do with Seabrook Station's Evacuation Plan, shouldn't someone in authority within the NRC or at FEMA be interested in deposing me so I can give my recollection of what I know took place at the meeting of 9-2-16 at the MA State Police Barracks in Newbury Massachusetts? **Please reply**

**Mr. Bower stated in the third Paragraph the following:** "Regarding your assertions involving other government entities in Massachusetts (i.e., the Governor, the Attorney General and the Massachusetts Emergency Management Agency (MEMA) and Massachusetts Public Safety departments) to whom you brought your emergency planning concerns to since September 2, 2016, it is not within **our purview** to investigate the alleged actions (or alleged lack of action) by state government entities."

**Comley response:** Isn't it part of the purview, goals and responsibilities of the NRC and FEMA to protect and act on Whistleblowers' nuclear safety concerns? **Please reply.** I hope the present Trump Administration at the NRC does not have the previous policy that was occurring during former NRC Executive Director, Victor Stello's watch at the Agency. **Please Reply.** NRC informants told me Mr. Stello was in favor of releasing Nuclear informants names to their employers when unsafe conditions at their plants were reported to the NRC. As you know, Mr. Barkley, this attempt by Stello to keep informants intimidated and silent from bringing their concerns public is documented in one of the NRC IG 6 investigations WTP brought to light during David Williams Term as the first NRC IG. Mr. Bower's letter of May 10, 2018, with 2 enclosures, **(all attached)** mentioned this very NRC IG Investigative report which involved whistleblowers who worked at TVA Watts Bar Nuclear Plant. This was included with and in the second of 2 enclosures entitled: "Email to Richard Barkley Dated March 1, 2018- more evidence to substantiate WTP's work with 1 of 6 investigative reports entitled: " WTP - Comley - Whistle-Blowers on Safety Risks Betrayed By NRC (ML15236A273441/484)."

**Mr. Bower stated in the 4th Paragraph of his letter of May 10, 2018 the following:** "While your past concerns are known to the Federal Emergency Management Agency (FEMA) Region 1 due to their past communications with you and by our providing carbon copies of some of the NRC's response letters to them and MEMA, Mr. Barkley provided you, by an email dated March 28, 2018, with FEMA's formal notification of a public meeting scheduled for April 6, 2018, following the Biennial Seabrook Emergency Exercise held on April 4, 2018. As we have informed you in previous correspondence and communications, **FEMA has jurisdiction of offsite emergency preparedness involving commercial nuclear power plants and they are ultimately the authority that must validate your assertions with the adequacy of emergency preparedness at Seabrook Station.** Therefore we thought that it would be best for you to share your concerns directly with FEMA Region 1 representatives before or following this meeting. It is our understanding you chose not to attend this meeting. On May 2, 2018, at the Public Annual Assessment Meeting for Seabrook Station, two NRC staff members from the NRC's Office of Nuclear Security and Incident Response (NSIR) that specialize in emergency preparedness were present for you to discuss your concerns."

**Comley's responses:** Since We The People's concerns are known due to the fact the NRC has provided Mr. Ford at FEMA with carbon copies of some of the NRC's response letters to WTP and MEMA, which Mr. Barkley provided to WTP, why hasn't anyone at FEMA, or at MEMA, to date, contacted WTP directly? **Please respond.** The reason I did not attend FEMA's public meeting scheduled for April 6, 2018, was due to 2 recent surgeries. At the meeting, May 2, 2018, concerning the Public Annual Assessment Meeting for Seabrook Station, (which to WTP's disappointment was not audio or video recorded as WTP requested and has been done in the past) I did have the pleasure of speaking with all of the members of NRC attendees who were at this assessment meeting May 2, 2018 attached. This included the 2 NRC staff members from the NRC's Office of Nuclear Security. During my testimony at this meeting **(2 attached related news articles)** on Seabrook Station, I spoke about WTP concerns about the plant, including the presence of the GAG ORDERS on the MA State Police and NH National Guard. I made sure WTP's safety concerns, including the information about these GAG ORDERS was given to every member of the NRC Attendees **(attached)** at this meeting, May 2, 2018. Every NRC member I spoke with after this meeting, including B. Welling, Deputy Director Division of Reactor Safety (DRS), assured me they would respond back to WTP Nuclear safety concerns including these attempts to silence First Responders. **WTP believes Whistleblowers should be protected for revealing truths, not ignored, intimidated or punished.** To date, no one from this NRC delegation who attended and who I talked with during this Public Annual Assessment Meeting, May 2, 2018, has responded as promised to WTP Nuclear Safety Concerns. **In addition, I still have not received any responses to WTP safety concerns sent by Mr. Barkley to NRC Chairwoman, Kristine L. Svinicki, including my request to meet with her. It should also be noted, President Donald T. Trump has first knowledge of evidence of these GAG ORDERS and Bogus Nuclear Parts which is captured on videos if you click on View Work on my web site: www.stephencomleysr.com**

**Mr. Bower Stated in his 5th Paragraph the following:** "On the issue of the NRC supporting past assertion by yourself and We The People, the office of Inspector general (OIG) maintains copies of their reports dating back to 1995 on the NRC's public website. Any of the six reports you wish to obtain prior to 1995 will need to be obtained from the OIG. The contact information for the OIG can be located on [WWW.nrc.gov](http://WWW.nrc.gov)."

**Comley's response:** Thank you for this contact information for the NRC IG's Office. I will request these NRC IG Investigation Reports which We The People's Brave Whistleblowers brought to light, **unless the NRC is willing to provide them to WTP. Please confirm.**

**Mr. Bower stated in his 6th Paragraph the Following:** "As previously stated to you back in February 2014 (ML14043A360), the NRC continues to have a vendor inspection program, which is being conducted by NRC's Office of New Reactors. Prior efforts in this area were the responsibility of the Office of Nuclear Reactor Regulation. **However given significant changes in personnel, including retirements, in the NRC organization since you first raised your concerns with counterfeit and substandard parts, it would be unproductive for us to search for who preciously managed that effort almost 30 years ago.** Current NRC's ongoing actions in this area were discussed in a generic communication to a wide audience in NRC regulatory Issue



summary (RIS) 2015-08 "Oversight of Counterfeit Fraudulent, And Suspect Items In The Nuclear Industry." dated June 24, 2015 (ML15008A191).

**Comley's response:** Mr. Barkley, I am sure you remember in my letter of July 4, 2014, with enclosures, to Glenn T. Dentel, Chief of Division of Reactor Projects, Branch 3, where I stated on Page 6 the following: "**I was informed by informants from the NRC staff investigation of unsafe conditions at nuclear plants were to be kept a PUBLIC SECRET always controlled by Victor Stello inside the NRC and away from the public eye as much as possible.**" The Counterfeit Substandard Parts Scandal was a prime example of this and happened with the investigation of the Three Mile Island (TMI) Accident in 1979, which Victor Stello had a hand in. I found Evidence of this TMI cover--up when I read the Investigative Interview conducted by Alan Rosenthal March 22, 1989, on behalf of Former NRC OI Deputy Director, Roger Fortuna, who Stated on Pages 170 -174 (**Enclosure H**) where Mr. Fortuna makes several references to the investigation he, with his team, was to conduct of allegations of masking the radiation count during the TMI disaster. Mr. Fortuna, at that time, worked for the DOJ and was in charge of conducting this investigation, **which Report DOJ has yet to release to the public.**

On pages 5, 6 and 7 of my letter of July 4, 2014, with enclosures, to Mr. Dentel concerned, "Counterfeit Substandard Parts built in most if not all U.S. Nuclear Plants during the Administration of former President Reagan."

On page 5 of my letter to Mr. Dentel I restated what he said in reply to my letter which was the following: " You also asked for the name of the staff member who was in charge of the NRC Inspection Program for parts Vendors. During that time period Victor Stello was Executive Director of the NRC."

In addition on Page 5 Mr. Dentel stated the following: "you also requested a list of counterfeit, and or substandard parts replaced or not replaced at Seabrook." Mr. Dentel response said: "**Regarding your request for a list of counterfeit and/or substandard parts, replaced or not replaced at Seabrook Station, the NRC does not retain such a list.**"

Page 6: "I request, once again, the name or names of who was made in charge of keeping track of when and what companies were suppling counterfeit substandard Parts to U.S. Nuclear plants during Victor Stello tenor when he was Executive Director of the NRC?"

**In all due respect to Mr. Bower's Statement,** " It would be unproductive for us to search for who previously managed that effort almost 30 years ago" (During Victor Stello's watch at the NRC concerning when and what companies were supply the Counterfeit Substandard Parts to U.S. Nuclear Plants.)

**Comley's respond: I happen to believe it would be very productive, and would not take that long, to discover who was in charge of this Vendor Inspection Program. We The People's informants, and I, are very hopeful, in the very near future some Responsible Elected Leader in Washington, such as who I have been In-touch with recently, Rep. Elijah Cummings,**

**Ranking Member of the House Oversight Committee and Investigations will call for a complete investigation of the Cover-up of the Counterfeit Substandard Nuclear Parts National Scandal, together with We The People's other Cover-ups by the NRC of other unsafe conditions at U.S. Nuclear Plants.**

Due to We The People's current and long term involvement concerning Bogus Nuclear Parts in U.S Nuclear Plants, we would appreciate if the NRC would continue to keep our organization informed by Distribution w/encl: (via e-mail) of current ongoing actions in the area of Vendor Inspection Program, which is being conducted by NRC's Office of New Reactors. **Please confirm.** WTP would also like to receive any copies of information, that is available, of what was discussed or sent out in a generic communication to a wide audience in the NRC regulatory issue summary (RIS) 2015-08 "Oversight of Counterfeit Fraudulent, And Suspect Items in The Nuclear Industry." dated June 24, 2015 (ML15008A191). **Please Confirm.**

**Mr. Bower stated in the last paragraph of his letter to We The People of May 10, 2018:** "Finally, as requested, I am sharing your concerns and this reply with the Office of the NRC Chairwoman for what ever action they deem appropriate. I am also sharing this reply with the NRC Office of Inspector General for any action they deem appropriate as well."

**Comley Responses:** As I stated earlier in my responses, I have not heard anything from, NRC Chairwoman, Kristine L. Svinicki, regarding WTP concerns or the many requests you have submitted to her. **One is whether Kristine L. Svinicki believes leaving special needs citizens behind in the event of a nuclear disaster is humane and acceptable by her. As you know Mr. Barkley this is the very issue which first started my over 32 year investigations of the NRC and the Nuclear Industry.**

In addition, pertaining to the current NRC IG, Hubert Bell, I have never been contacted by him or anyone from his office. I am very troubled by Mr. Bell's non-action to We The People's charges of unsafe conditions at most, if not all, Nuclear Plants including Seabrook Station. As Mr. Bower's letter so states, Mr. Bell's office has been notified of WTP concerns including the fact I provided a transcript of one of my Tape-recordings to MA Attorney General, Maura Healey's 4 member Legal Team during my meeting with them, October 18, 2017. This 4 Member Legal Team, which included MA IG's Chief of Staff, Mike Firestone, was supposedly set up to investigate WTP concerns at Seabrook Station and cover-ups by the NRC of unsafe conditions at U.S. Plants Nation-wide.

**I believe Mr. Bell's decision in not contacting me about WTP Nuclear Safety Concerns is not only irresponsible but is an Obstruction of Justice. One example of this charge is outlined in my letter of July 4, 2014, with enclosures, to Mr. Dental. This includes proof of cover-ups by some of the highest officials during the Reagan/Bush Administration and their involvement in attempting to Cover-up the presence of Counterfeit Substandard Nuclear Parts still built in U.S. Plants. A current example of impeding or ignoring what Mr. Bell has also been made aware by NRC in correspondence, is having my meeting October 18, 2017, with Maura Healey's 4 member Legal Team. I provided this team with my letter of July 4, 2014 with**

**enclosures to Mr. Dentel and a copy of a transcript of one of my tape-recordings. (Mr. Bell certainly must suspect this Transcript is just one of the tape-recordings I now admit to having which through NRC IG and DOJ efforts had me under 2 Federal Subpoenas to seize during the 6 years I was in MA Federal Court.)**

In closing, Mr. Barkley, thank you once again for your attention, understanding and action you continue to take concerning these important Nuclear Safety Matters. If you or anyone at the NRC needs further clarification or comment from me, please do not hesitate to contact me.

Mr. Barkley,

You, Mr. Bower and Mr. Sheehan are well aware I was very disappointed the NRC meeting, held on May 2, 2018, was neither Audio or Video Tape Recorded in order that my and other public testimony would be made for the public record in Nuclear Regulatory Commission (NRC) ADAM's Document Room.

As you and other members of the NRC panel who presided over the NRC Hearing May 2, 2018 in Hampton NH, know I testified about many of We The People's (WTP) nuclear safety concerns some involving Rudolph Giuliani's and his staff's participation (see attachment) in the Counterfeit Substandard Nuclear Parts Scandal. I also testified and admitted I have the many Tape-Recordings the NRC and Department of Justice (DOJ) **supposedly** wanted to seize during the over 6 years I was under 2 Federal Subpoenas in MA Federal Court with the charge of, "Conspiring to Topple the NRC with Roger Fortuna, (former) Deputy Director of the NRC's Office of Investigations, and, if I did not turn over these Tape-Recordings of High Officials, I could be jeopardizing the safety of the American People and the Security of Nuclear Plants across the Country."

I am attaching for the public record more quotes from other of WTP's Tape-Recordings, letters from former White House Chief, Leon Panetta to DOJ and the letter from Former NRC IG Deputy Director, Leo Norton to the Federal Bureau of (FBI) Investigations. As you and many others at the NRC know, these letters asked for a investigations of the NRC and President Reagan which were never conducted. You never know Special Counsel, Robert Mueller just maybe now or in the future will be interested in conducting an investigations of all the cover-ups involved in the Counterfeit Substandard Nuclear Parts Scandal, especially since, it involved Rudolph Giuliani. Individuals can cover-up the truth for so long but it always eventually comes out.

I also testified at the NRC Meeting May 2, 2018, WTP provided MA AG Maura Healy's 4 Member Legal Team, which includes her Chief of Staff, Mike Firestone, with a copy of a transcript of one of WTP's Tape-recordings. WTP also, since officially meeting with the 4 member Legal Team October 18, 2017, instructed them not to release this transcript unless

they had WTP's permission first.

I was informed recently by Mr. Bower and Mr. Sheehan during my phone calls to them, and by you at the meeting May 2, 2018, "It is not a NRC Policy to audio or visually Tape-record public meetings." If public testimony is not recorded, how can anyone, who is not able to attend NRC Public Hearings, be made aware of any public testimony about nuclear concerns? **Well, its about time all NRC Hearings, especially Public ones, are tape recorded visually and with audio!!!**

I am sure, Mr. Barkley, you recall the last time We The People testified at a NRC hearing was December 18, 2013. This occurred just a week before Christmas, when most citizens were very busy getting ready for the holidays. This certainly prevented many who wanted to testify from doing so. Some activists mentioned to me, the NRC arranged to have this hearing on this date intentionally so very few would show up. But having a public hearing would give the NRC an opportunity to put on a show that they were interested in what the public safety concerns were. When I heard of this date, as you know, I called you and demanded you arrange to have this NRC meeting on 12/18/13 Audio and Visually Tape-Recorded. You did just that, which I fully appreciated.

When I found out the upcoming NRC hearing was to be held May 2, 2018, I called Mr. Sheehan at least a week before to make sure the meeting would be recorded. Unfortunately Mr. Sheehan did not return my phone messages. Because of this, I called him once again and made the request to have this meeting audio and visually tape-recorded. Mr. Sheehan replied and said he did not return my calls previously due to the fact he was informed Mr. Barkley was handling all of my concerns and requests, as he was instructed to do by NRC Chairwoman, Kristine Svinicki. Mr. Sheehan then informed me he would call you and make you aware WTP wanted this May 2, 2018, meeting recorded.

When I arrived May 2, 2018, in Hampton, NH, at the Best Western Plus Conference Center, I found out Upper Valley Audio Visual from Maine was retained by you to prepare audio for the NRC Hearing 5-2-18. I believe Upper Valley was also the same company you had retained for the last NRC Hearing at which I gave testimony on December 18, 2013.

I understand the cost for Upper Valley Audio Visual in making arrangements for the May 2, 2018, hearing for taking public comments regarding the Safety of Seabrook Station was at a cost of \$1800.00, and \$1500.00 was the cost for the Best Western Plus Conference Hall. These expenses are at taxpayers' expense. Surely it would not have been much more expense to have Upper Valley Audio Visual to have been retained to video and audio tape-record this hearing as they did December 18, 2013.

Mr. Barkley, you recently informed me by e-mail that the previous questions, requests and comments you have or are preparing for NRC Chairwoman, Kristine L. Svinicki, to answer and make comments on will be done by May 10, 2018. Please add one more to WTP's requests and comments to NRC Chair Svinicki, in keeping with The NRC's Policy Statement, "Enhancing Public

Participation in NRC Meetings, effective May 28, 2002", please have Chairwoman Svinicki consider adding the following language, :All Public Participation in NRC Meetings, effective immediately, will be Audio and Visually recorded".

Please respond to my comments above and please notify We The People when this letter to you with attachments will be posted in the NRC's ADAMS Public Document Room.

Thank you once again, Mr. Barkley, for your attention and co-operation regarding these very important nuclear safety matters.
