I am writing to follow-up with you regarding the letter from the U.S. Nuclear Regulatory Commission (NRC) sent on June 8, 2018.¹ In that letter, I requested that you contact the NRC staff concerning the potential previous use of your property at [

] by Mr. Charles Olivier. Mr. Olivier may have used this property as a storage location for Superior Instrument Service, Inc., a wholesaler of aircraft instruments.

As stated in that letter, based on information provided to the NRC staff by the State of Michigan, World War II era aircraft gauges and aircraft flight instruments may have been stored on your property. We requested that you contact the NRC concerning any material that was left at your home by the previous owner. As we discussed over the phone, you noted that no material was left on your property by the previous owner. You further stated that you had completed extensive renovations to the property since your purchase. Additionally, the staff has no indication that any aircraft gauge and flight instrumentation repair activities occurred at your property and the information you provided indicated that if material had been stored on your property it has since been removed. Therefore, the staff does not believe that there are any public health and safety concerns at your property.

In the previous letter, the NRC staff also asked if you had any forwarding address or contact phone numbers for Mr. Charles Olivier. During our previous discussions, you informed us that Mr. Olivier had passed away since selling the property and that you did not have contact information for any of his relatives.

Please note that no further actions are required from you concerning this matter. Thank you again for your prompt response to our previous letter.
