Title: PUBLIC PREDECISIONAL ENFORCEMENT CONFERENCE WITH PROVIDENCE ALASKA MEDICAL CENTER (PAMC)

Date(s) and Time(s): December 17, 2018, 12:00 PM to 03:30 PM

Location: Webinar

Category: This is a Category 1 meeting. The public is invited to observe this meeting and will have one or more opportunities to communicate with the NRC after the business portion of the meeting but before the meeting is adjourned.

Purpose: The purpose of this predecisional enforcement conference is to discuss the four apparent violations identified by the NRC: (1) failure to monitor occupational exposure of workers from licensed and unlicensed sources of radiation and account for external employment for purposes of occupational dose; (2) failure to provide adequate instructions to workers associated with exposure to radiation; (3) failure to provide reports to workers regarding personnel exposure information; and (4) failure to implement required elements of the radiation protection program. These apparent violations are discussed in NRC Inspection Report 030-13426/2018-002, (EA-18-133), dated November 2, 2018 (ADAMS Accession ML18306A565).
