## Dear Hanson:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2017-019 on September 28, 2017, to determine whether Operations Department management at Calvert Cliffs Nuclear Power Plant deliberately failed to follow fire protection staffing requirements. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that that Operations Department management deliberately failed to follow the relevant requirements.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
