SUBJECT: YANKEE AIRCRAFT MUSEUM RESPONSE TO THE U.S. NUCLEAR

REGULATORY COMMISSION REQUEST FOR INFORMATION

Dear Ms. Osborne:

I am writing in response to your letter dated July 25, 2018<sup>1</sup>, which responds to the U.S. Nuclear Regulatory Commission (NRC) staff's request for information dated June 19, 2018<sup>2</sup>, regarding radium gauges and dials.

In your response you stated that to the best of your knowledge, the Yankee Aircraft Museum does not have any gauges that contain radium from historic Would War II aircraft and that yearly inspections are performed within your artifact collection to ensure that there are no broken or cracked instruments within the collection. However, you discuss that if any gauges or instruments are damaged and contain radioactive material, you will contact the NRC. Additionally, you state that the Yankee Aircraft Musuem will not accept new artifacts into the permanent collection if there would potentially be any radioactive material contained in the artifact. Your response is reasonable, and the NRC staff has no further comments.
