Dear Mr. Shea:

The NRC has completed its end-of-cycle performance assessment of the Browns Ferry Nuclear Plant, Units 1, 2 and 3, reviewing performance indicators (PIs), inspection results, and enforcement actions from January 1, 2018, through December 31, 2018. This letter informs you of the NRC's assessment of your facility during this period and its plans for future inspections at your facility. The NRC concluded that overall performance at your facility preserved public health and safety.

Browns Ferry Nuclear Plant, Units 1, 2 and 3 were in the NRC Regulatory Response Column for the first quarter of CY 2018 for the greater-than-Green inspection finding in the Security cornerstone identified in the second quarter of 2017. On February 20, 2018, the NRC completed a review of your corrective actions for the greater-than-Green inspection finding in the Security cornerstone, using Inspection Procedure 95001, "Supplemental Inspection for One or Two White Inputs in a Strategic Performance Area." The NRC's inspection was documented in NRC inspection report (IR) 05000259, 260, 296/2018440, which is publically available in ADAMS Accession No. ML18051A745. Based on the results of this inspection, the NRC determined the performance at Browns Ferry Nuclear Plant, Units 1, 2 and 3 returned in the Licensee Response Column (Column 1) of the Reactor Oversight Process (ROP) Action Matrix in the second quarter of CY 2018.

The NRC determined the performance at Browns Ferry Nuclear Plant, Units 1, 2 and 3 during the most recent quarter was within the Licensee Response Column, the highest performance category of the NRC's ROP Action Matrix, because all inspection findings had very low safety significance (i.e., Green), and all PIs were within the expected range (i.e., Green). Therefore, the NRC plans to conduct ROP baseline inspections at your facility.

In addition to the ROP baseline inspections, we also plan on conducting infrequently performed inspections which include two Initial License Examinations, Safety Conscious Work Environment and Confirmatory Orders Follow-up inspections. The NRC will be in contact with your staff to schedule completion of Temporary Instruction (TI) 2515/194, "Inspection of the Licensee's Implementation of Industry Initiative Associated With the Open Phase Condition Design Vulnerabilities In Electric Power Systems (NRC Bulletin 2012-01)."

The NRC intends to complete this inspection in 2019.

The enclosed inspection plan lists the inspections scheduled through December 31, 2020. The NRC provides the inspection plan to allow for the resolution of any scheduling conflicts and personnel availability issues. Routine inspections performed by resident inspectors are not included in the inspection plan. You should be aware that the agency is pursuing potential changes to the ROP, including changes to engineering inspections (SECY-18-0113, "Recommendations for Modifying the Reactor Oversight Process Engineering Inspections"). Should these changes to the ROP be implemented, the engineering and other region-based inspections are subject to change in scope, as well as schedule, beginning in January 2020. The inspections listed during the last twelve months of the inspection plan are tentative and may be revised. The NRC will contact you as soon as possible to discuss changes to the inspection plan should circumstances warrant any changes.
