INTRODUCTION

Inservice inspection (ISI) of scheduled ASME Section XI components and their supports at Pacific Gas and Electric Company's Diablo Canyon Power Plant (DCPP) was completed during the Unit 1 twenty-first refueling outage (1R21) from February 2019 through March 2019. 1R21 was the second outage in the first period within the fourth 10-year ISI interval.

This Owner's Activity Report, OAR-1, complies with the provisions of Code Case N-532-5 as approved by Regulatory Guide 1.147, Revision 18.

The OAR-1 Report covers any mid cycle work completed after July 19, 2017, and any applicable 1R21 work completed prior to and including April 18, 2019.
