Gentlemen:

This is to inform you of a change to information contained in NRC Inspection Report Nos. 50-325 IER 90-01 and 50-324/90-01 paragraph 3.b of Report Details. During an NRC inspection at BNP on January 8-12, 1990, the NRC inspectors were provided with a copy of a plan and schedule to evaluate existing warehouse stock and installed items purchased as commercial grade to ensure their acceptability. This plan and schedule was subsequently translated into the body of the subject Inspection Report and indicated a completion date of July 15, 1990.

Subsequent to the NRC inspection, CP&L decided to evaluate existing warehouse stock and installed items using a central team of CP&L personnel evaluating all three CP&L Nuclear Plants in parallel. The team was assembled and began work on May 08, 1990. The team's evaluation is on-going with an expected final completion date of February 28, 1991, disregarding any expanded sampling that may be necessary.

Mr. Starkey's memorandum of January 11, 1990 as referred to in the subject Inspection Report should be considered superceded by this letter.
