Gentlemen:

Attached is License Change Application #8 requesting amendment of Operating License NPF-82 for the Shoreham Nuclear Power Station (SNPS). This amendment application is made to modify the full power Technical Specifications (NUREG-1357, April 1989, as amended) that the Long Island Lighting Company (LILCO) presently holds for SNPS by deleting the Independent Safety Engineering Group (ISEG) and its associated administrative controls.

Justification for this License Change, as more fully described in the attachment, is based on SNPS non-operating and defueled condition, the continued costs associated with maintaining an ISEG, and the limited number of design basis accidents (DBAs) and limited number of Commission issuances and Industry Operating Experience issuances applicable to SNPS in our present defueled condition.

Approval by the Commission's Staff of LILCO's previously submitted license amendment request (reference 1) for the removal of operating authority would make this current license amendment moot. However, inasmuch as the review and approval schedule for the January 5, 1990 (reference 1) license amendment is indeterminable at this time, LILCO wishes to take advantage of the immediate relief available upon NRC approval of this current license amendment request.

LILCO's determination of the acceptability of the above change applies only to SNPS in its defueled condition and is not considered to be an irreversible step toward decommissioning and can be re-established if fuel is ever to be placed back into the SNPS reactor.
