The controlled plant drawing deficiencies discussed in this report had been identified as a concern both in your Unit 1 Startup Assessment Report, dated May 29, 1990, and in NRC Inspection Report 50-317/90-08 and 50-318/90-08, dated June 4, 1990. Our review of this issue indicates that your efforts to date have not been fully successful. We encourage your continued attention to this matter.

Within the scope of this inspection, no violations were observed.
