Madam Secretary, I believe we have two items for affirmation. Would you please lead the Commission through the affirmation items?

ANNETTE VIETTI-COOK: Yes. The first item is on SECY-19-0049, Crow Butte Resources, Inc. (Marsland Expansion Area), Petition for Review of Licensing Board Panel-19-2, Licensing Board Panel-18-3, and Memorandum and order Granting Summary Disposition. The

Commission is being asked to act on a Memorandum and Order addressing the Oglala Sioux Tribe's petition for review of the Atomic Safety and Licensing Board's Initial Decision and two interlocutory orders in the licensing proceeding for Crow Butte's proposed Marsland Expansion Area.

The Commission has voted to approve a Memorandum and Order that denies the petition for review.

ANNETTE VIETTI-COOK: The second item is SECY-20-0028, United States

Department of Energy (Export of 93.35% Enriched Uranium) Petitions Seeking Leave to
Intervene and Request for Hearing). This matter involves the application of the U.S.

Department of Energy, National Nuclear Security Administration (DOE/NNSA) to export 4.455

kilograms of uranium-235 in 4.227 kilograms of uranium with a maximum enrichment of 93.35%.

This highly enriched uranium would be exported to Belgium, specifically to the Institute for

Radioelements, over a period ending in 2022. The Commission is being asked to act on a

Memorandum and Order responding to requests for hearing and petitions to intervene filed by

NorthStar Medical Radioisotopes, LLC, Nuclear Threat Initiative, Curium US, LLC, and Dr. Alan

J. Kuperman on the export license application filed by DOE/NNSA.

The Commission has voted to approve a Memorandum and Order that denies the

requests for hearing and petitions to intervene and directs the Office of International Programs

to issue the export license.

ANNETTE VIETTI-COOK: Yes. This matter involves the application of the U.S.
