Dear Sir:

By Reference A Florida Power Corporation (FPC) submitted fire endurance test reports for Mecatiss fire barriers. By Reference B FPC submitted Thermo-Lag and Mecatiss fire barrier ampacity derating test reports. FPC stated that these test reports were proprietary to FPC and requested that they be withheld from public disclosure. In a subsequent telephone communication, the NRC notified FPC that the affidavits provided were insufficient in that they did not specifically state that the reports were owned by FPC.

Attachment A is a replacement affidavit for Reference A, and Attachment B is a replacement affidavit for Reference B. The replacement affidavits specifically state that FPC is the owner of the subject reports. We apologize for the deficiency and trust that the corrected documents will provide sufficient justification to withhold the reports from public disclosure.


