This refers to the announced preoperational physical security inspection conducted by Messrs. J. R. Kniceley and J. L. Belanger of this office on September 30 - October 4, 1985, of activities at Perry Nuclear Power Plant, Unit 1, authorized by NRC Construction Permit No. CPPR-148 and to the discussion of our findings with Mr. A. Kaplan and other members of your staff at the conclusion of the inspection.
