ISI (Inservice Inspection) Program: Relief Requests

The purpose of this submittal is to request NRC review and approval of the attached proposed relief requests applicable to the Unit No. 1 and No. 2 Ten-Year ISI Programs. The current Unit 1 interval ends on September 20, 1997, and the Unit 2 interval ends on November 16, 1997.
