ROUTE RE-APPROVAL FOR SPENT FUEL SHIPMENTS

Gentlemen:

The purpose of this letter is to request an extension to the spent fuel rail transportation route approval, provided by Mr. Charles E. Haughney's letter dated April 19, 1995. The letter provided a two-year approval for the transportation route of irradiated reactor fuel by rail from the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2, and from the Brunswick Steam Electric Plant (BSEP), Units Nos. 1 and 2, to the Shearon Harris Nuclear Power Plant (SHNPP).

In order to support desired shipping schedules, Carolina Power & Light (CP&L) Company requests that the NRC renew the route approvals by April 19, 1997.


