As requested during that meeting, the enclosed Staff Requirement Memorandum (SRM) response, dated May 25, 1999, provides the actions the NRC staff plans for continued oversight of the safety-conscious work environment (SCWE) and employee concerns program (ECP) at the Millstone Nuclear Power Station (Millstone). The plan includes criteria to determine if increased regulatory actions are warranted. The plan also provides for periodic assessments until ongoing organizational changes and further improvements to the ECP/SCWE at Millstone are achieved.
