The supplemental inspection was performed as the result of one Yellow Performance Indicator (PI) in the Initiating Events Cornerstone of the NRC's Action Matrix. This regulatory performance meeting will discuss the performance deficiencies and proposed corrective actions associated with the Yellow Performance Indicator. Following the meeting with Entergy, the NRC will respond to public questions on specific performance issues at the plant and the agency's role in ensuring safe plant operations.
