Mr. Overly/Mr. Bradley:

With the licensee's exemption request to be submitted requesting the postponement of the EP Exercise (and associated inspection) to a date to be determined in CY2022, the following annual inspection procedures still need to be completed at Waterford before the end of CY2021. **Therefore** the purpose of this e-mail is to transmit a request for information (RFI) in support of an inspection of recent changes to Waterford's Emergency Plan/Implementing Procedures and to complete the annual Performance Indicator (PI) Verification of the three EP-related PIs. As such, the attached Request for Information <u>supplements and revises</u> that which was previously sent to the station by Sean Hedger, on August 4, 2021 (ML21216A456).

The inspection will be conducted using IP 71114.04 and IP 71151, and it is my intention to complete this activity during the months of November and December 2021, and document it in the 4th Quarter integrated report for Waterford.
