In accordance with 10 CFR 50.54(p)(2), Dairyland Power Cooperative (DPC) is submitting the explanation of changes for the July revision of the La Crosse Boiling Water Reactor (LACBWR) Independent Spent Fuel Storage Installation (ISFSI) Physical Security Plan (PSP) and Appendices. This revision has been determined to not decrease the safeguards effectiveness of the current security plan. This revision is being submitted to reflect changes that will be implemented at the time of license transfer from LaCrosseSolutions to DPC.
