MEETING REGARDING THE V.C. SUMMER NUCLEAR

STATION, DOCKET NO. 50-395, MEETING NUMBER 20230620

On May 25, 2023, the Nuclear Regulatory Commission (NRC) conducted a live hybrid (virtual and in-person) meeting concerning the V. C. Summer Nuclear Station. The purpose of the meeting was to provide opportunities for the public to discuss the annual assessment for the period of January 1, 2022, through December 31, 2022.

The meeting was held both remotely through the Microsoft Teams application and in-person at McCrorey-Liston School of Technology, 1978 State Hwy 215 S, Blair, SC. Additionally, a call-only telephone bridge line was available.
