This matter involves the application of the U.S. Department of Energy and National

Nuclear Security Administration to export up to 130 kilograms of highly enriched uranium to

Framatome's facility in Romans-sur-Isère, France, where the uranium will be fabricated into fuel

and then transferred to the Institut Laue-Langevin for use in its High-Flux Reactor. The

Commission is being asked to act on a Memorandum and Order that would respond to a

request for hearing and petition to intervene filed by Dr. Alan J. Kuperman on the export license

application.

The Commission has voted to approve a Memorandum and Order that denies Dr.

Kuperman's hearing request. Would you please affirm your votes after I call your name?
