#### Chairman Diaz' Comments on SECY-04-0199

I approve the staff's request to issue a license to Foster Wheeler Environmental Corporation, for the interim storage of spent fuel at the Idaho spent fuel (ISF) facility, in accordance with 10 CFR Part 72.

The paper states that the staff will: 1) develop appropriate additional security measures (ASMs) to be provided to the licensee after issuance of the Part 72 license, but well in advance of facility operation; and 2) consider Interim Compensatory Measures issued to other similar licensed facilities when determining the appropriate ASMs for the ISF facility. In developing these ASMs, the staff should consider the degree to which current DOE security measures and practices meet the intent of previous Commission direction and staff practices for spent fuel storage facilities.

Finally, I agree with the staff's plan to advise the Commission of any new policy issues regarding the imposition of ASMs for this facility, before issuing the ASMs.
