Chairman Klein's Comments on SECY-07-0155

I approve the staffs recommendation to deny the petition for rulemaking to reconcile the Nuclear Regulatory Commission's (NRC) Generic Environmental Impact Statement (GEIS) for License Renewal of Nuclear Plants, issued in May 1996, with the National Academy of Sciences (NAS) Health Risks from Exposure to Low Levels of Ionizing Radiation: Biological Effects of Ionizing Radiation (BEIR) VII, 7th Ed., 2005 report.

In 2005, the staff reviewed the BEIR VII report and concluded in SECY-05-0202 that the scientific evidence in the report is consistent with the system of radiological protection that NRC uses to develop its regulations; that, there is a linear, no-threshold dose response relationship between exposure to ionizing radiation and the development of cancer in humans. The staff further concluded that when compared to its previous edition of the BEIR report, BEIR VII did not contain new and significant information that warranted amending NRC regulations or the GEIS. I agree with the staff that the current regulations contain adequate radiation safety limits, and thus continue to ensure adequate protection of the public and occupational workers. Therefore, I approve denying the subject petition.

Commissioner Jaczko's Comments on SECY-07-0155

Denial of a Petition for Rulemaking to Reconcile NRC Generic Environmental Impact Statement for Nuclear Power Plant Operating License Renewal Applications with the National Academy of Sciences Health Risks from Exposure to Low Levels of Ionizing Radiation: Biological Effects of Ionizing Radiation VII, Seventh Ed., 2005 Report (PRM-51-11)

I approve of the staff's recommendation to deny the petition for rulemaking to reconcile the Nuclear Regulatory Commission's (NRC) Generic Environmental Impact Statement for License Renewal of Nuclear Power Plants, with the Biological Effects of Ionizing Radiation (BEIR) VII report, in part, because the issue is not ready for Commission consideration. I believe there are larger regulatory issues involved in changing the agency's approach to radiological protection which requires a larger evaluation of the standards and the development of a supporting technical basis that involves more than the License Renewal program. Additionally, the International Commission on Radiological Protection (ICRP) has yet to publish its final recommendations, and the final ICRP recommendations should be considered as part of evaluating whether the protection standards or methods should be modified.

The Advisory Committee on Nuclear Waste and Materials has reviewed the ICRP draft recommendations and recommended that the Commission consider adopting technical improvements such as new radiation weighting factors for neutrons and protons once the ICRP recommendations are finalized. I also believe that the staff should more closely evaluate the potential influence of gender on radiation sensitivity once the ICRP publishes its recommendations. Thus, I look forward to the staff's recommendations to the Commission concerning its comprehensive evaluation of the BEIR reports, ICRP recommendations, including other relevant radiation protection studies, whether the agency should make enhancements to its radiation protection standards and methods.

Commissioner Lyons' Comments on SECY-07-0155

I approve the staff recommendation to deny the subject petition for rulemaking subject to the following comments.

The staff had previously reviewed the Biological Effects of Ionizing Radiation (BEIR) VII report and concluded that the findings in the report were consistent with the system of radiological protection that the NRC uses to develop its regulations. The staff concluded that the NRC's existing regulations continue to be protective of public health and safety and the environment and that none of the findings in the report warrant initiating any immediate change to NRC regulations or guidance. The petition provided no information that would challenge this earlier conclusion and therefore the petition should be denied.

However, as noted in the subject SECY paper, the staff is in the process of updating the Generic Environmental Impact Statement for License Renewal of Nuclear Plants (GEIS) through a planned rulemaking to include lessons learned from reviewing plant specific environmental impact reports and recent scientific studies, including the BEIR VII report. So, although the petition is denied, the BEIR VII report will be considered during the previously scheduled update of the GEIS. I believe the petitioner and other stakeholders should be apprised of this fact.

On an editorial note, the last sentence of the second full paragraph on page 11 of the *Federal Register* Notice, "The discussion in the GEIS about the 1 rem per year is not to represent that the risk to occupational workers." Is incomplete.
