#### Chairman Macfarlane's Comments SECY-13-0033, "ALLOWING INTERIM OPERATION UNDER TITLE10 OF THE CODE OF

#### FEDERAL REGULATIONS SECTION 52.103"

I approve the staff recommendation that the Commission delegate the authority to issue the required finding under 10CFR52.103(g) to the staff. The staff has implemented formal procedures under NRO Instructions NRO-REG-103, "Inspections, Tests, Analyses, and Acceptance Criteria Closure Verification Process" and NRO-REG-102, " Prioritization of Inspections, Tests, Analysis, and Acceptance Criteria (ITAAC) for Inspection" that ensure that a thorough review of ITAAC closure is conducted for all licensees. The option of delegating the 10CFR52.103(g) finding to the staff is recognized in 10CFR2.304(j) and there is adequate precedence in the previous delegations by the Commission of the authority to issue Combined Licences and Operating Licenses to the staff.

In addition, I acknowledge the four issues associated with interim operations under the pendency of an ITAAC hearing that the staff raised, specifically:

- If interim operation is approved, the staff will rely on the environmental evaluation of operational impacts performed in the Combined License (COL) EIS unless the interim operation would introduce new and significant information.
- For operational programs that are specified as being implemented on a 10CFR52.103(g) finding, these programs would be implemented during interim operation.
- ITAAC maintenance activities would no longer be required following the 10CFR52.103(g) finding.
- If a petition to modify the terms and conditions of a COL is received (10CFR52.103(f)), this petition needs to be coordinated with decisions having the effect of allowing operation (including interim operation).

I join Commissioner Ostendorff in commending the staff for their efforts to address these issues in a timely manner to support the potential need during the ITAAC closure and preparation for operation for the Vogtle and Summer units. The staff should continue to develop these processes to ensure that, in practice, the actions of the Commission in determining adequate protection during the period of interim operation cannot be construed as prejudicing the staff's findings with respect to ITAAC closure.

Given the lack of clarity regarding processes for ITAAC hearings, I urge the staff, OGC and OCAA to work together to develop a range of options for ITAAC hearing formats for Commission review and approval.

#### Commissioner Magwood's Comments on SECY-13-0033, "Allowing Interim Operations under <u>Title 10 of the Code of Federal Regulations Section 52.103</u>"

In the subject SECY, staff informed the Commission of issues related to implementation of Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) for new nuclear power plants, and specific issues associated with interim operations while ITAAC hearings are pending. I appreciate staff's continuing efforts to anticipate process questions associated with 10 CFR Part 52 that can be resolved at an early date.

I approve staff's request that the Commission delegate to staff the finding on all 10.CFR 52.103(g) acceptance criteria, consistent with existing regulation and precedent. As staff points out, this delegation permits the Commission to exercise its familiar role as arbiter in the resolution of contested issues related to ITAAC hearings.

I echo the Chairman's concern about the present lack of clarity regarding the processes and procedures for ITAAC hearings and recommend that staff develop a range of options for Commission review and approval.

I appreciate the staff's efforts to clarify the issues associated with interim operation under 10 CFR 52.103(c). It is prudent to resolve these issues early to ensure that efficient processes are in place to implement this provision, if needed, for the Vogtle and Summer new reactors. The staff should continue to proactively identify issues and bring them to the attention of the Commission, as full implementation of the ITAAC program and processes are carried out for the first time.
