Subject: ANNUAL REPORT ON COMMISSION ADJUDICATION

### Purpose:

To provide the Commission a perspective on the adjudicatory caseload and the Commission's role in adjudication from January through December 1995.

## Introduction:

As part of OCAA's monitoring role over adjudicatory matters, I am providing the Commission this report on agency adjudications for calendar year 1995. This report updates information contained in the last report (SECY-95-196, July 26, 1995) and is based on the information compiled in the attached charts. The first three charts cover various aspects of the Commission's adjudicatory work during 1995. Chart 1 presents information regarding the seventeen substantive decisions (CLIs) issued by the Commission during this period, Chart 2 identifies the thirteen final decisions of the Atomic Safety and Licensing Board ("ASLBP" or "Board") in 1995, and Chart 3 lists and describes the four new proceedings that have been referred to the ASLBP during that year.

I am also attaching three charts which provide an overview of agency adjudication for the 4½ years following the creation of OCAA in July 1991. Chart 4 provides information about all proceedings which the Commission has referred to the ASLBP during that period, Chart 5 provides a numerical breakdown of those same proceedings, divided into substantive and procedural categories, and Chart 6 provides a breakdown of Commission decisions issued after June 1991, divided into substantive and jurisdictional categories.

## Discussion:

### A. General Observations and Trends

Over the past 4½ years (July 1991 through December 1995), the Commission has referred 62 new proceedings to the ASLBP. As measured by the number of final decisions issued by the Board (17, 8, 14, and 13 in 1992, 1993, 1994, and 1995, respectively), the Board's workload over the last two years has risen slightly. However, as measured by the number of significant Commission decisions, the Commission's adjudicatory workload has declined somewhat over the last two years -- 22, 26, 16, and 17 in 1992, 1993, 1994, and 1995, respectively.

In addition, the number of new adjudicatory proceedings has declined significantly during 1995 compared to the number in the previous three calendar years. Only 4 new proceedings were referred to the Licensing Board in 1995 as compared to the 18, 11, 20 new proceedings referred in 1992, 1993 and 1994, respectively. It is hard to pinpoint any particular reason for this decline in new proceedings. The decline may reflect merely a fluctuation in caseload or may represent a new trend.

The caseload continues to shift away from reactor licensing matters and toward enforcement. Enforcement proceedings account for 28 of the 62 proceedings referred the ASLBP since July 1991. The next largest portion of the caseload is composed of materials licensing proceedings, although the number is much smaller (16 cases). Consistent with this shift, three-quarters of proceedings (44 cases) are (or were) subject to formal adjudicatory procedures in Subpart G to 10 C.F.R. Part 2, in part because enforcement proceedings are currently subject to the formal rules. The 16 materials licensing proceedings are (or were) subject to the informal hearing procedures in 10 C.F.R. Part 2, Subpart L, and the two program fraud adjudications were governed by Part 13 of the Commission's regulations.

Of the 62 proceedings referred to the ASLBP since July 1, 1991, 49 have been concluded. Twenty-five were terminated after settlement, 7 after voluntary withdrawal of the hearing request, 6 after involuntary dismissal, and 3 after denial of a request for hearing. The remaining 8 closed cases were decided on the merits. Thirteen of the cases referred to the Board after July 1, 1991 and one case referred prior to that date remain pending 1 — 3 before the Commission, 10 before the Board, and 1 with portions before both the Commission and the Board.

During the 4%-year period from July 1991 through December 1995, the Commission has taken significant action in 76 instances on various motions, petitions, appeals, or other requests for relief, and took <u>sua sponte</u> action in 11 instances. Thirteen of the 87 Commission decisions involved appeals or petitions for review of the ultimate merits of a proceeding.

# B. Adjudication in 1995

### 1. Commission Actions

As shown in Chart 1, the Commission in the last year issued seventeen substantive decisions. Six of these decisions responded to appeals or petitions for review of Licensing Board University of Missouri, CLI-95-01, Sequoyah Fuels Corp., CLI-95-02; Dr. James Bauer, CLI-95-03; Babcock & Wilcox, CLI-95-04; Kenneth Pierce, CLI-95-06; Louisiana Energy Services, CLI-95-07. Five others addressed motions for reconsideration of earlier Commission decisions or motions for stays. <u>Georgia Power</u>, CLI-95-05, -09; <u>University of Missouri</u>, CLI-95-08, -11, -17. addition, the Commission issued two decisions pursuant to its original jurisdiction, to address a court decision's effect on the decommissioning of the Trojan and Yankee Nuclear Power Stations. Portland General Electric Co., CLI-95-13, and Yankee Atomic Electric Co., CLI-95-14, both responding to the ruling in Citizens Awareness Network v. NRC, 59 F.3d 284 (1st Cir. 1995).

Two more decisions involved discretionary interlocutory appeals — one regarding a provision of a protective order, <u>Sequoyah</u> <u>Fuels Corp and General Atomics</u>, CLI-95-16, and the other concerning the soundness of a Board ruling compelling the licensee to produce its attorney's notes on communications with one of the licensee's employees, <u>Georgia Power Co.</u>, CLI-95-15. Another decision addressed interlocutory appeals filed by staff and the licensee "as of right" regarding the admissibility of a contention and the granting of standing. <u>Georgia Institute of Technology</u>, CLI-95-12. Last, in <u>Georgia Institute of Technology</u>, CLI-95-10, the Commission exercised its <u>sua sponte</u> authority to issue a decision lifting a housekeeping stay on discovery and taking certain other procedural steps to advance the proceeding.

Of these seventeen decisions, only <u>University of Missouri</u> (CLI-95-01) involved Commission review of the ultimate merits of a proceeding. In that lengthy and complex decision, the Commission essentially affirmed the Presiding Officer's grant of a license for possession and use of material by the University in its TRUMP-S experiments. In addition, the parties in that proceeding filed an unprecedented three rounds of reconsideration petitions. All Commission decisions other than those in <u>University of Missouri</u> either denied petitions for review or

resolved interlocutory matters.

Four cases were under active Commission review at the end of 1995. The first, <a href="Kerr-McGee">Kerr-McGee</a> Chemical Corp., involves a long-standing dispute between Kerr-McGee, the City of Chicago and the State of Illinois regarding Kerr-McGee's license amendment application to dispose of uranium mill tailings by on-site burial at the licensee's West Chicago Rare Earths facility. Kerr-McGee no longer intends to pursue those disposal plans and consequently all parties now agree that the case is moot. The only remaining issue is whether the Commission should vacate a 1991 Appeal Board decision (ALAB-944) on the disposal issue.

In <u>Cleveland Electric Illuminating Co.</u> (LBP-95-17), the Licensing Board ruled that the approval process under 10 C.F.R. Part 50 Appendix H, § II.B.3 for changes to a licensee's reactor vessel surveillance capsule withdrawal schedule violates the notice and hearing provisions of Section 189a of the Atomic Energy Act. The NRC staff and the licensee have sought review of LBP-95-17, arguing that Appendix H does not require prior NRC approval of any change to a withdrawal schedule. In addition, the licensee claims that this decision has far-reaching consequences and may result in numerous approvals required under NRC regulations being treated as license amendments.

The Commission also has before it petitions for review of the Board's approval of a settlement agreement between the NRC staff and the Sequoyah Fuels Corporation (SFC). Sequoyah Fuels Corp. and General Atomics, LBP-95-18. The proceeding stems from a staff enforcement order holding SFC and its parent, General Atomics, jointly and severally liable for decontamination and decommissioning of the SFC facility near Gore, Oklahoma. The petitioners objects to the settlement's provisions exempting SFC from certain funding requirements. The staff and SFC argue that the settlement is a favorable arrangement because SFC has agreed to commit all of its present and future assets and revenues to clean up of the SFC facility.

Finally, <u>Georgia Institute of Technology</u> was, at the end of 1995, technically still pending before the Commission. However, the Board has issued a memorandum and order denying the petition to intervene; the petitioners have chosen not to seek Commission review of that order; and the period for Commission <u>sua sponte</u> review expired on January 2, 1996, without Commission action.

#### 2. ASLBP Actions

The ASLBP issued thirteen final orders in 1995. Only three of these orders -- <u>Babcock & Wilcox</u>, <u>Kenneth Pierce</u>, <u>Cleveland</u>

Electric Illuminating Co. -- were decisions on the merits.<sup>2</sup> Tn Kenneth Pierce, the Board conducted an evidentiary hearing pursuant to Subpart G and found that the staff had failed to substantiate the charges alleged in its enforcement order. As a result, the Board lifted all sanctions imposed against Mr. Pierce by the staff's order. The Commission later denied the staff's petition for review of the Board's order. Babcock & Wilcox was a Subpart L proceeding in which the Presiding Officer authorized renewal of a license to use nuclear materials at a repair and maintenance facility in Parks Township, Pennsylvania. Commission denied the intervenors' petition for review of the Presiding Officer's final order. In Cleveland Electric <u>Illuminating Co.</u>, the licensee sought approval for a license amendment to remove from the Perry Nuclear Power Plant's technical specifications the schedule for the withdrawal of reactor vessel material surveillance specimens. The Board approved the amendment and the intervenors have sought Commission review. As noted in the preceding section, review is pending.

All four of the new proceedings which the Commission referred to the Licensing Board during the last year (listed on Chart 3) are ongoing. Advanced Medical Systems is subject to the informal hearing procedures in Subpart L. This proceeding involves renewal of the license for possession of material at the licensee's London Road facility in Cleveland, Ohio. two proceedings are enforcement actions involving orders imposing civil penalties. Oncology Services Corp. and Radiation Oncology Center at Marlton. These cases are subject to the formal hearing procedures in Subpart G. Although the enforcement proceedings are separate actions involving separate licenses, they may be tangentially interrelated because of an asserted overlap in ownership. Finally, Northeast Nuclear Energy Co. is a reactor license amendment proceeding subject to the Commission's Subpart G procedures. This case concerns a proposed amendment that would permit the licensee routinely to offload its entire core fuel load into the spent fuel pool during refueling outages.

In addition to the pending cases identified on Chart 3, the other active proceedings currently before the ASLBP are:

Georgia Power Co. (Vogtle) (transfer of ownership)
Gulf States Utilities Co. (River Bend) (transfer/merger)
Louisiana Energy Services (uranium enrichment facility)
Sequoyah Fuels Corp. & General Atomics (decomm'n funding)
Sequoyah Fuels Corp. & General Atomics (organiz'l change)
Georgia Institute of Technology (license renewal)

- " Other matters include requests for hearing or other relief in export licensing (Part 110) matters or involving regulated activities not subject to an existing proceeding.
