Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending April 4, 2008

Vendor Inspection and Joint-Utility Audit at RTP Corporation (RTP)

From March 25 - 28, 2008, Division of Engineering (DE) staff observed a joint-utility audit and conducted a limited scope inspection at RTP in Pompano Beach, Florida. RTP provides safety-related data acquisition systems to the nuclear industry. The purpose of the audit observation was to assess the Nuclear Procurement Issues Committee (NUPIC) quality assurance audit process used for approving suppliers of safety-related and commercial-grade dedicated components to the nuclear industry. The DE staff inspected selected portions of RTP's program to implement the provisions of 10 CFR Part 21, "Reporting of Defects and Noncompliance."

Emergency Response Data System (ERDS) Meeting

On March 26, 2008, the Division of Policy and Rulemaking and Office of Nuclear Security and Incident Response staff conducted a public meeting with NEI and utility representatives to discuss issues associated with proposed rulemaking to enhance the NRC's ERDS. The purpose of the meeting was to engage the public early in the rulemaking process to incorporate feedback into technical bases development. Public feedback received included: (1) delay rulemaking until outstanding issues are resolved, (2) enhancements should be cost beneficial as determined by cost-benefit analyses, (3) NRC should install ERDS enhancements on its power-plant simulators in Chattanooga to determine enhancement feasibility and cost before finalizing rulemaking, (4) the Electronic Plant Reference Data system should be updated electronically and be kept up-to-date, (5) the amount of ERDS data supplied to states should be limited to that necessary for the states to do required assessments, (6) NRC and industry should pilot the ERDS enhancements before finalizing rulemaking, and (7) the industry needs time to implement any rulemaking.

Oconee Steam Generator (SG) Tube Wear Root Cause Meeting

On March 27, 2008, Division of Component Integrity staff participated in a Category 1 public meeting with Duke Energy Power Company, LLC (Duke) representatives to discuss the root cause findings for wear in the tubes in the replacement SGs at all three Oconee units. Duke and Babcock & Wilcox Canada (B&W), the manufacturer of the Oconee SGs, have determined that the most probable cause of the tube wear is due to the tubes vibrating and impacting the tube support plates. Duke and B&W have developed a conceptual repair to reduce the amount of tube vibration and plans to make a decision on the path forward by late summer 2008.

Meeting on Fire Induced Multiple Spurious Actuation

On March 27, 2008, Division of Risk Assessment staff conducted a public meeting with representatives from Nuclear Energy Institute (NEI) to discuss the staff's proposal to address fire induced circuit faults and multiple spurious actuations. The staff's proposal provides a regulatory basis for where prescriptive fire protection features, such as barriers and suppression systems, are required for the protection of safe shutdown trains. In addition, the staff's proposal addresses where other fire protection features, such as manual actions, may be used to assure

safe shutdown capability. The staff plans to schedule another meeting with NEI and industry representatives to obtain feedback on the proposed plan prior to submitting the proposal to the Commission.

NRC Observation of Ultra Sonic Flow Meter Operation

During April 1-4, 2008, Division of Safety Systems staff observed the operation of the Westinghouse CROSSFLOW Ultra Sonic Flow Meter (UFM) at the Ft. Calhoun plant. Omaha Public Power District is attempting to recertify the UFM for use in conjunction with the Ft. Calhoun measurement uncertainty recovery power uprate.

Monthly License Renewal Meeting

On April 2, 2008, Division of License Renewal staff conducted a Category 2 public meeting to discuss generic license renewal topics and license renewal process improvements. The staff conducts monthly meetings to discuss current topics of interest related to license renewal activities. The purpose is to ensure good communication between the staff, industry, and the public regarding license renewal activities.

Interim Staff Guidance (ISG) on Limited Work Authorizations (LWA)

On April 1, 2008, the staff issued proposed Combined License/Early Site Permit (COL/ESP) ISG-004 on implementation of the revised LWA rule. This ISG will replace the previous guidance issued in June 2007 in Regulatory Guide (RG) 1.206, "Combined License Applications for Nuclear Power Plants (LWR Edition)," concerning requests for LWAs submitted as part of an early site permit or combined license application. Upon receiving public comments, the staff will evaluate and disposition the comments, as appropriate. Once complete, the staff will issue the ISG for use. The NRC staff will also incorporate the approved COL/ESP-ISG-004 into the next revisions of RG 1.206 and NUREG-0800, "Standard Review Plan for the Review of Safety Analysis Reports for Nuclear Power Plants," and related guidance documents.

Approval of Mitsubishi's Criminal History and Background Information Procedure

By letter dated April 2, 2008, the NRC staff approved Mitsubishi's procedure titled, "Gathering and Protecting Criminal History and Background Information for Purposes of Access to Safeguards Information of MNES." The staff's approval allows Mitsubishi Nuclear Energy Systems (MNES) to use this procedure to determine the trustworthiness and reliability of individuals for whom fingerprinting and a Federal Bureau of Investigation criminal history records check is not reasonably expected to yield sufficient criminal history in order to determine whether to grant access to Safeguards Information (SGI). Additionally, the staff will perform an inspection of any facility where Mitsubishi proposes to use and store SGI, both inside and outside the United States. The staff has already approved of two locations within the United States.

Public Scoping Meeting Regarding Environmental Review of Bellefonte COL Application

On April 3, 2008, NRC staff held two public meetings in Scottsboro, Alabama, to solicit comments on the scope of the staff's environmental review of the COL application for the Bellefonte site. Approximately 125 people attended each meeting, including representatives of the NRC staff, Pacific Northwest National Laboratory, Tennessee Valley Authority, State and local governments, the nuclear industry, and members of the public. About 40 people provided comments. In addition, the NRC staff hosted an informal "open house" for one hour prior to each meeting to answer questions about the COL application review process. The public comment period for scoping ends on April 25, 2008. After the conclusion of the comment period, the staff will evaluate the comments received, develop the scope of the draft environmental impact statement (EIS), and prepare the draft EIS. The draft EIS is currently scheduled to be published in the spring of 2009.

Public Meeting on Total System Performance Assessment Model of Yucca Mountain

On March 31, 2008, NRC and the U.S. Department of Energy (DOE) staff held an Appendix 7 meeting in Las Vegas, Nevada on topics related to post-closure performance of a geologic repository at Yucca Mountain. The meeting allowed NRC and DOE staff to exchange information on aspects of the DOE's Total System Performance Assessment model, while observed by interested members of the public. No commitments between NRC and DOE were made and no written reports or meeting summaries will be issued. The meeting was observed by representatives of the State of Nevada, various Nevada county governments, and other stakeholders.

Global Threat Reduction Initiative Reactor Conversion Program

On March 31, 2008, NMSS, the Office of Nuclear Reactor Regulation, and the Office of Nuclear Security and Incident Response staff met with three National Nuclear Security Administration (NNSA) representatives. At this public meeting, the agency staff and NNSA representatives discussed the potential licensing of a new manufacturing facility, which will produce low-enriched uranium (LEU) research and test reactor fuels. The NMSS staff described the special nuclear material licensing process, with emphasis on the National Environmental Policy Act, 10 CFR Part 70 requirements, and safeguards regulations. NNSA published a request for interest in the *Federal Register* on February 29, 2008, soliciting expressions of interest from companies capable of manufacturing this fuel. Responses are due on May 30, 2008.

Public Meeting on Yucca Mountain Unsaturated Zone Process Uncertainty

On April 1, 2008, NRC and DOE held an Appendix 7 meeting, in Las Vegas, Nevada, on topics related to post-closure performance of a geologic repository at Yucca Mountain. The meeting focused on DOE's treatment of uncertainties in its models for unsaturated zone processes. The meeting was open for observation by stakeholders and interested members of the public.

Technical Exchange on Yucca Mountain Groundwater Infiltration

On April 2, 2008, NRC and DOE held a technical exchange at the NRC Hearing Facility, in Las Vegas, Nevada, on topics related to post-closure performance of a geologic repository at Yucca Mountain. The meeting focused on DOE's approach for infiltration at Yucca Mountain. The meeting was open to stakeholders and interested members of the public.

Update: Onsite Observation Visit to Savannah River Site Saltstone Facilities

During the week of March 24, 2008, NRC staff conducted an observation visit for the Saltstone facilities at the U.S. Department of Energy's (DOE) Savannah River Site. This visit was conducted as part of NRC responsibilities under the National Defense Authorization Act for Fiscal Year 2005, and was a follow-up to a previous visit that was conducted in October 2007, during which several open items were identified. The staff reviewed several documents, toured the salt waste disposal facilities, and met with DOE and contractor personnel to discuss technical issues such as vault integrity, wasteform composition, waste sampling, tracking of inventory, and environmental monitoring. The DOE provided significant information regarding its plans to address many of the open items identified during the staff's October 2007 visit. NRC staff will issue a publicly available observation report that will discuss its observations resulting from the visit.

Revision of Fee Schedules; Fee Recovery for FY 2008; Correction (Al28 – Part 171)

On March 28, 2008, the Office of the *Federal Register* published a notice (73 FR 16747), correcting various printing errors made in a proposed rule published February 13, 2008 (73 FR 8508) concerning NRC's fee recovery for FY 2008. The notice reprints several fee tables to correct missing headings and other typographical errors.

Fitness for Duty (FFD) Programs; Final Rule (AF12 – Part 26, PRM-26-1, and PRM-26-2)

On March 31, 2008, NRC published a final rule (73 FR 16966) amending its FFD regulations to update these requirements and enhance consistency with advances in other relevant Federal rules and guidelines. The rule also grants, in part, a petition for rulemaking (PRM–26–1) submitted by Virginia Electric and Power Company (now Dominion Virginia Power) on December 30, 1993, by relaxing several required FFD program audit frequencies, and partially grants a petition for rulemaking (PRM–26–2) submitted by Barry Quigley on December 28, 1999. The rule is effective April 30, 2008; however, licensees and other applicable entities may defer implementation of the rule, except for Subparts I and K, until March 31, 2009.
