Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending January 16, 2009

Motor Operated Valve (MUG) and Air Operated Valve (AUG) Users Group Meetings

From January 5-9, 2009, the staff attended the MUG and AUG annual meetings. Several papers were presented by industry representatives on recent experience with motor-operated valve (MOV) magnesium rotors and corrective actions in response to NRC Information Notice 2008-20, "Failures of MOV Actuator Motors with Magnesium Alloy Rotors," dated December 8, 2008. The staff discussed the status of MOV regulatory activities and the results of recent MOV inspections at the MUG meeting. In addition, the staff discussed solenoid valve diagnostics and evaluation of air-operated valve diagnostic test results at the AUG meeting.

Public Meeting with Industry Steam Generator Task Force

On January 8, 2009, staff participated in a Category 2 Public Meeting with the Nuclear Energy Institute (NEI) and the industry's Steam Generator Task Force to discuss technical issues regarding steam generator tube integrity. The industry representatives described their analyses of the applicability of international operating experience (e.g., plug failure, fatigue cracking) and several other technical issues including their efforts associated with monitoring noise in the inspection data, clarifying the technical specification inspection requirements, and developing guidance for detection of foreign objects and associated wear.

Beaver Valley Power Station (BVPS), Units 1 and 2, License Renewal Safety Evaluation Report (SER) with Open Item

On January 9, 2009, the staff issued the BVPS, Units 1 and 2, SER with Open Item related to the BVPS Units 1 and 2, license renewal application. By letter dated August 27, 2007, FirstEnergy Nuclear Operating Company (FENOC) submitted an application requesting the extension of the BVPS operating licenses for an additional 20 years. The SER has one open item (regarding the suitability of medium voltage cable for submergence). The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards Subcommittee on February 4, 2009, to discuss the SER with Open Item.

Public Meeting on Steam Generator Tube H* Analysis

On January 9, 2009, staff participated in a Category 2 Public Meeting with NEI and the industry to discuss the status of the industry's H* analysis approach, which is being used to develop the technical basis for limiting the extent of inspections in the tubesheet region in units with thermally-treated Alloy 600 steam generator tubes. The discussion included the staff's technical issues with H* and the industry's schedule for completion of activities and submission of documentation.

Public Meeting on Generic Safety Issue (GSI)-191

On January 15, 2009, the staff held a Category 2 public meeting to discuss the status of the resolution of GSI-191 (PWR sump clogging). The meeting was attended by licensees, including PWROG, NEI, Westinghouse, and sump strainer vendors. The staff described the current status of the review of licensee responses to Generic Letter 2004-02 and presented the overall closure plan for GSI-191. The staff also discussed the status of an ongoing issue on licensee proposals to reduce zones of influence for damage to insulation and the status of resolution of in-vessel downstream effects.

Office of Nuclear Regulatory Research (RES) Items of Interest Week Ending January 16, 2009

Meeting with Industry Regarding Research Activities on Probability of Detection (POD) Curves

From January 7-8, 2009, the staff participated in a public meeting hosted by the Office of Nuclear Regulatory Research to discuss with EPRI the status of ongoing research activities to develop POD curves for certain ultrasonic examination techniques currently used for inspections. The ultimate goal of the project is to develop a more robust, fully probabilistic approach to GDC-4, "Environmental and Dynamic Effects Design Bases." Follow on teleconferences will be held in the near future to further discuss the issues and schedules for providing POD data.

Microsoft Consulting Services

On January 9, 2009, as a result of a competitive negotiated acquisition under the GSA Federal Supply Schedules, a time and materials type delivery order, NRC-DR-042-09-005, was awarded to Info Reliance Corp. of Fairfax, Virginia to provide Microsoft consulting services in support of the Enterprise Project Management to NRC Region II. The goal of this effort is to develop a unique software tool that will allow Region II to integrate and manage its new reactor licensing schedules with licensees' schedules. The period of performance is from January 9, 2009, to August 14, 2009, with no option periods, and the value of the award is \$937,544.80.

Part 51 Information Collection

On January 5, 2009, the 60-Day Federal Register Notice (FRN) was published for the draft renewal of the information collection titled, "10 CFR 51, Environmental Protection Regulations for Domestic Licensing and Related Regulatory Functions." This FRN is the first phase of renewing the information collection for this regulation. After this FRN comment period, a second FRN will be published for 30-days before the draft renewal becomes final.

Public Document Room Japanese Visit

On January 13, 2009, staff from the Information and Records Services Division (IRSD) hosted four individuals from Tokyo, Japan who represented the Secretariat of the Nuclear Safety Commission, Cabinet Office, the Japan Nuclear Energy Safety Organization (JNES), and Japan Nuclear Utilities Service Co., Ltd. The visitors had experience in searching ADAMS (both Webbased and Citrix-based versions), and asked questions about searching techniques and technical aspects of the system. Public Document Room (PDR) librarians answered their questions, demonstrated the PDR public web site and helped with ADAMS searches on the public computers in the reading room. The visitors also received a copy of the PDR Fact Sheet with the mission statement and contact information.
