Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending February 13, 2009

American Society of Mechanical Engineers Boiler and Pressure Vessel Code (ASME Code) Meetings

During the week of February 2, 2009, the staff participated in the ASME Code, Sections III, V, and XI meetings. The staff participated in: (1) meetings regarding code cases which address inspection and repair requirements for mitigating the effects of primary water stress corrosion cracking in nickel-based dissimilar metal butt welds (DMBWs) in reactor coolant pressure boundary piping of pressurized water reactors, (2) discussions on the coordination of these mitigation and inspection requirements for DMBWs as related to current 10 CFR Part 50.55a rulemaking activities, and (3) meetings regarding a code case to be used by licensees for designing, fabricating, joining and inspecting replacement piping made from high density polyethylene. These issues are related to a number of current and anticipated operating plant licensing actions.

License Renewal Application for Duane Arnold Energy Center

On February 10, 2009, the staff completed the acceptance review of the license renewal application and its supplement for the Duane Arnold Energy Center. The staff determined that the application contains sufficient information for docketing. On October 1, 2008, the staff received a license renewal application from Florida Power and Light Energy Duane Arnold, LLC, requesting the extension of the Operating License for Duane Arnold Energy Center for an additional 20 years. Duane Arnold Energy Center is a boiling water reactor designed by General Electric with a current operating license that expires on February 21, 2014.

Public Meeting with the Nuclear Energy Institute

On February 11, 2009, the staff held a Part 26 Quality Control/Quality Verification public meeting at the NRC Headquarters to initiate public involvement in development of a regulatory basis for a potential proposed rule as per a staff requirements memorandum. The meeting was attended by the Offices of NRR, Nuclear Regulatory Research and the General Counsel and by members of the Nuclear Energy Institute.

Office of Nuclear Material Safety and Safeguards (NMSS) Items of Interest Week Ending February 13, 2009

Meeting with the Native American Forum on Nuclear Issues

On February 6, 2009, in response to an invitation by the Native American Forum on Nuclear Issues, NRC staff presented an overview of the process and current status of the NRC technical review of the Department of Energy High Level Waste Repository license application. The meeting was held at the University of Nevada, Las Vegas.

Office of Nuclear Regulatory Research (RES) Items of Interest Week Ending February 13, 2009

Meeting with the Nuclear Energy Institute (NEI) on Draft Regulatory Guide (RG) 5.71, "Cyber Security Programs for Nuclear Facility"

On February 11, 2009, staff met with NEI to review the final 6 out of 208 industry comments on the draft RG 5.71 (previously known as DG-5022). RG 5.71 provides key cyber attributes and program elements to the licensee and/or vendor on how their performance based cyber security plan could meet regulations (10 CFR 73.54) with high assurance of adequate protection from a cyber attack. The successful completion of these meetings provides better understanding and clarity for industry on the guidance in RG 5.71.

List of Approved Spent Fuel Storage Casks: MAGNASTOR Addition, Confirmation of Effective Date (AI51 - Part 72)

On February 4, 2009, the NRC published a document (74 FR 5983) in the *Federal Register* confirming the effective date of February 4, 2009, for the direct final rule in the *Federal Register* that adds the NAC International Inc. MAGNASTOR cask system to the "List of Approved Spent Fuel Storage Casks." This direct final rule allows the holders of power reactor operating licenses to store spent fuel in this approved cask system under a general license.

Procurement Oversight Training and Support Services

On February 6, 2009, as a result of a sole source negotiated acquisition, a hybrid requirements type General Services Administration delivery order, NRC-DR-38-09-703, was awarded to Business Management Research Associates located in Fairfax, Virginia, to provide consulting and training services to the NRC's Procurement Oversight Team. Development of a training course is a fixed price, and the consulting services are priced on a labor hour basis. The total ceiling price of the delivery order is valued at \$404,024.29, with a period of performance from January 9, 2009, through January 8, 2010, with one option year.
