#### Office of Federal and State Materials and Environmental Management Programs (FSME) Items of Interest Week Ending May 22, 2009

#### Meetings Held on Proposed GE-Hitachi Global Laser Enrichment Facility

On May 19, 2009, FSME and the Office of Nuclear Material Safety and Safeguards staff held two public meetings to solicit public comments on the scope of the Environmental Impact Statement for the proposed General Electric-Hitachi Global Laser Enrichment facility. The facility would be built on the existing General Electric-Global Nuclear Fuels America site near Wilmington, North Carolina. Staff discussed the processes for the safety and environmental reviews. Also during the week, staff met with local elected officials and State agencies and visited the proposed facility.

#### Staff Meets with Yukon River Intertribal Watershed Council (YRITWC)

On May 19, 2009, FSME staff and management met with members of the YRITWC, located in Alaska's Yukon River Watershed, to discuss their expectations for future communications and communications protocols with NRC. The Council has followed closely Toshiba's interest in, and technical presentations to NRC regarding, development of its proposed 10 megawatt 4S reactor. The town of Galena, Alaska, has expressed an interest to Toshiba in being considered as a possible location for the 4S reactor.

#### Office of Nuclear Regulatory Research (RES) Items of Interest Week Ending May 22, 2009

#### NRC Staff Participates in the International Workshop on Defense-in-Depth for Electrical Systems

From May 12-14, 2009, staff from the Offices of RES, Nuclear Reactor Regulation, and New Reactors participated in the Committee on the Safety of Nuclear Installations (CSNI) Defense-in-Depth for Electrical Systems and Grid Interaction Workshop at the Organization for Economic Cooperation and Development Headquarters in Paris, France. The purpose of the workshop was to share the findings from the Lessons Learned Task Group that was formed in response to the major electrical event on July 27, 2006, at Forsmark-1 nuclear station in Sweden. A final report on the lessons learned from the Forsmark event along with the feedback from this workshop will be published by the Nuclear Energy Agency/CSNI by the end of 2009. Continued NRC participation in future working groups or technical meetings in the electrical design area will enhance future collaborations in (1) onsite power system robustness, (2) coping with electrical transients, (3) electrical grid risk management, and (4) control system robustness. The next meeting is planned for September 2009.

#### Publication of Draft Regulatory Guide 1237 (DG-1237) "Guidance on Making Changes to Emergency Plans for Nuclear Power Reactors"

On May 19, 2009, RES staff issued DG-1237 to provide an opportunity for public comments. This is a proposed new regulatory guide that provides guidance on the implementation of 10 CFR 50.54(q), "Conditions of Licenses," with respect to making changes to emergency response plans for nuclear power reactors. #### Interoffice Seismic Retreat

On May 20, 2009, RES staff held a seismic retreat as a preliminary step to develop an information basis for updating the NRC Seismic Research Program Plan. RES staff presented brief snapshots of over 20 ongoing research projects. The participants then engaged in open discussion about the projects' objectives, products, schedule, and responsiveness to user need requests. The participants (particularly those from the user office) were asked to identify additional issues or needs and potential mid-project redirections. The retreat was attended by 35 earth scientists and engineers from RES, NRO, NRR, and the Office of Nuclear Material Safety and Safeguards.

#### Meeting with National Aeronautics and Space Administration (NASA)

On May 20, 2009, the Director, RES and other RES managers met with representatives of NASA to discuss areas of possible mutual research interest between NASA and NRC. Topics included risk/reliability, uncertainty analysis, precursor analysis, fire, digital instrumentation and control, safety metrics and goals, decision criteria and safety culture issues. In the future, NRC plans to utilize the "NASA-NRC MOU [Memorandum of Understanding] for Collaborative

Research in Risk and Reliability Analysis Methods and Applications" to the maximum extent possible in all the areas discussed with NASA.

#### Office of Information Services (OIS) Items of Interest Week Ending May 22, 2009

#### Managing Electronics Records 2009 National Conference

From May 17 – 20, 2009, staff from the Information and Records Services Division attended the 2009 Managing Electronic Records (MER) Conference held in Chicago, Illinois. The conference addressed the issues and challenges of managing electronic records from the three perspectives of operational, legal, and technical. The sessions provided innovative solutions by presenting case studies and best practices on items such as new methodologies for records retention development and implementation, strategic planning for comprehensive records management, the governance challenge of MS SharePoint, email and instant message management, electronic discovery, and metadata management.

#### Controlled Unclassified Information Council - Working Group

On May 19, 2009, staff from the Information and Records Services Division participated in a working group of the Controlled Unclassified Information (CUI) Council at the National Archives and Records Administration, the Executive Agency for implementing the Federal-wide CUI framework. The purpose of the meeting was to discuss and further develop the specified dissemination instructions for export controlled information and to begin discussion on the specified dissemination instructions for security information (SI). Specified dissemination instruction for each type of information rather than develop their own instruction. The group determined that there were only a few types of security information that would need a specified dissemination instruction and the CUI Office could develop what was needed without further input from the group. The next meeting of this working group will be on June 2, 2009, to review the draft instruction for security information and begin discussion on the instruction for information not releasable to foreign nationals.

#### National Archives and Records Administration Information Sessions

During the month of May 2009, Information and Records Services Division staff have been attending the National Archives and Records Administration information sessions on the Archives and Records Centers Information System (ARCIS) for Washington National Records Center (WNRC) customers. These sessions have included brief updates on how the system has been deployed at other centers, a general overview on changes the new system will bring for WNRC customers, and a question and answer period. ARCIS will be the mechanism used by the NRC to request retrieval of paper records and is also being considered as a possible replacement for the current system which tracks paper records and box locations.
