<u>List of Approved Spent Fuel Storage Casks: MAGNASTOR® System, Revision 2; Proposed</u> Rule and Direct Final Rule, 10 CFR Part 72 (RIN 3150-Al91; NRC-2011-0008)

On November 14, 2011, the NRC published a proposed rule (76 FR 70374) and a direct final rule (76 FR 70331) in the *Federal Register* to amend its spent fuel storage cask regulations by revising the NAC International, Inc. MAGNASTOR® System listing within the "List of Approved Spent Fuel Storage Casks." Amendment No. 2 will revise: (1) Technical Specification (TS) 3.3.2 to reduce the transportable storage canister removable surface contamination limits; (2) TS 4.1.1 to add various boron-10 areal densities for use with Pressurized Water Reactor and Boiling Water Reactor baskets and to replace the fuel tube orthogonal pitch with the minimum fuel tube outer diagonal dimension; (3) Table 2.1-2, "ASME Code Alternatives for MAGNASTOR® components," of the Final Safety Analysis Report to correct the code reference; and (4) Appendices A and B of the TSs to make editorial corrections. Comments on the proposed rule are due by December 14, 2011. The final rule is effective January 30, 2012.

Retrospective Review Under Executive Order 13579: Initial Plan for Retrospective Analysis of Existing Rules, 2 CFR Chapter XX, 5 CFR Chapter XLVIII, and 10 CFR Chapter I (NRC-2011-0246)

On November 16, 2011, the NRC published a *Federal Register* notice (76 FR 70913) making available its initial plan for retrospective analysis to determine whether any existing regulations should be modified, streamlined, expanded, or repealed. This action is part of the NRC's voluntary implementation of Executive Order 13579, "Regulation and Independent Regulatory Agencies," issued by the President on July 11, 2011. The purpose of the NRC's review is to make its regulatory program more effective in achieving its regulatory objectives. The NRC will not institute a public comment period until calendar year 2012 to reflect, as appropriate, any Commission decisions related to the Fukushima Task Force Report.

Movable and Demountable Walls

On November 17, 2011, as a result of a non-competitive Federal supply schedule solicitation, a fixed price blanket purchase agreement (NRC-HQ-12-A-10-0002) was awarded to Transwall Office Systems of West Chester, Pennsylvania, for movable and demountable walls. The period of performance is from December 1, 2011, to November 30, 2012, with four one-year option periods. The total estimated value is \$300,000, inclusive of all options.

Systems and Ancillary Furniture, Including Related Services

On November 17, 2011, as a result of a competitive Federal supply schedule solicitation, a fixed price blanket purchase agreement (NRC-HQ-12-A-10-0001) was awarded to Allsteel Inc. of Muscatine, Iowa, for systems and ancillary furniture, along with program management, design, delivery, and installation services for Three White Flint North and the subsequent renovation of One White Flint North. The period of performance is from November 17, 2011, to November 16, 2012, with four one-year option periods. The total estimated value is \$16,851,969, inclusive of all options.

Operation Warfighter (OWF) Internship Event

On November 16, 2011, staff from the Program Management, Policy Development, and Analysis Staff attended an OWF internship event at Bethesda Naval Medical Center. The Department of Defense sponsors temporary assignments and internships for members of the military who have been injured in service or have fallen ill. This program gives them the opportunity to benefit from work while they are undergoing treatment or therapy at military hospitals. The OWF program is one way to provide recuperating service members with work so they have a meaningful activity outside the hospital, and provides a formal means of transition back to the military or civilian workforce. OIS has participated in six of these internship events during the past year and has interviewed many service members. Given the recent consolidation of the Walter Reed medical facility and Bethesda Naval Medical Center into the Walter Reed National Military Medical Center, and its close proximity to NRC headquarters, OIS hopes to sponsor some of the wounded warriors for internships in the very near future.

Meeting with Robatel Technologies, LLC

On November 14, 2011, Robatel Technologies, LLC, met with the Division of Spent Fuel Storage and Transportation to present the new design features of the Model No. RT-100 package as a Type B(U)-96 waste (filters, resins) package. Structural, thermal, and shielding topics were discussed as well as benchmarking issues. Robatel is currently planning to submit its quality assurance program for approval under Part 71 in the first days of January 2012. A minimum of three pre-application meetings will be scheduled between December 2011, and March 31, 2012, before the Model No. TR-100 package application is submitted for review. This is the first time that Robatel is requesting an NRC certification.

Pre-Application Meeting with Transnuclear, Inc. (TN)

On November 17, 2011, staff of the Division of Spent Fuel Storage and Transportation, held a public meeting with TN. The purpose of the pre-application meeting was to discuss plans for a revision to Certificate of Compliance No. 9302 for the Model No. NUHOMS® - MP197HB transportation package. Specifically, the application will be to expand currently authorized package configurations to include high burnup fuel and request burnup credit. Detailed technical discussions were held regarding an NRC letter of unresolved issues dated November 2, 2011. TN agreed to reevaluate what they plan to submit and the timeframe at a later date.

2011 Chemical and Biological Defense Science and Technology (CBD S&T) Conference

On November 14-18, 2011, the Defense Threat Reduction Agency will host the 2011 CBD S&T Conference, in Las Vegas, Nevada. Some of the Minority Serving Institutions (MSI) funded by the NRC have been selected to present at this conference which is specifically designed to allow participants the opportunity to examine the best and new dynamic developments in basic and applied research within the chemical and biological defense landscape. It also gives them the opportunity to interact and collaborate with other researchers concerning the medical and physical sciences related to chemical and biological defense and to conduct program analysis that other Federal agencies may deem critical to their respective missions.
