#### Office of Administration (ADM) Items of Interest Week Ending December 23, 2011

#### NRC Region IV Office Administrative Support and Clerical Services

On December 15, 2011, as a result of a non-competitive 8(a) solicitation, a firm fixed price type contract (NRC-HQ-12-C-31-0023) was awarded to The Spearhead Group, Inc. of Houston, Texas. The contractor will provide the NRC's Region IV office in Arlington, Texas, with administrative support and clerical services. The period of performance is from January 1, 2012, through December 31, 2012, with three 1-year option periods. The total estimated value of the contract is \$560,572, inclusive of all options.

Options for Developing the Regulatory Basis for Streamlining Non-Power Reactor License Renewal and Non-Power Reactor Emergency Preparedness; Notice of Public Meeting; 10 CFR Part 50 (RIN 3150-AI96; NRC-2011-0087)

On December 16, 2011, the NRC posted in the *Federal Register* (76 FR 78173) a notice for a public meeting that was held on December 19, 2011, to discuss with affected stakeholders the proposed options for developing the regulatory basis for streamlining non-power reactor license renewal and non-power reactor emergency preparedness. This meeting was a follow-up to the NRC's public meeting held September 13, 2011, in Idaho Falls, Idaho, to discuss establishing the technical basis for proposing rulemaking to streamline the non-power reactor license renewal process, options for reorganizing the structure of regulations that pertain to non-power reactors, and potential enhancements to emergency preparedness requirements.

Regulatory Changes to Implement the United States/Australian Agreement for Peaceful Nuclear Cooperation: Corrections; Final Rule; Correcting Amendments; 10 CFR Part 40 (RIN 3150-AI95; NRC-2011-0072)

On December 20, 2011, the NRC published in the *Federal Register* (76 FR 78805) correcting amendments to a final rule published on November 8, 2011, (76 FR 69120) that amended the NRC's regulations to implement the 2010 "Agreement between the Government of Australia and the Government of the United States of America Concerning Peaceful Uses of Nuclear Energy." The present NRC action is necessary to relocate a new section added by the final rule and to make a related conforming change to the final rule. This correction was effective December 20, 2011.

#### Meeting on Accepting Externally-Issued Identity Credentials

On December 20, 2011, the Computer Security Office and OIS staff attended a meeting at the White House Conference Center hosted by the General Services Administration and the Office of Management and Budget (OMB). The meeting was in response to a memorandum from the Federal Chief Information Officer, dated October 6, 2011, regarding "Requirements for Accepting Externally-Issued Identity Credentials." ## Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending December 23, 2011

## Acceptance of License Renewal Application (LRA) for Grand Gulf Nuclear Station (GGNS)

On December 16, 2011, staff completed the acceptance review of the license renewal application for GGNS Unit 1. The staff determined that the application contains sufficient information for docketing. On November 1, 2011, the staff received the LRA from Entergy Operations, Inc., requesting the extension of the operating license for an additional 20 years beyond the current 40-year term. GGNS is a boiling-water reactor designed by General Electric with a current operating license that expires November 1, 2024. The staff plans to hold public information sessions on January 31, 2012, in Port Gibson, Mississippi, to describe the license renewal process and accept scoping comments for the environmental review. Acceptance of the LRA, which is published in the *Federal Register*, begins a 60-day opportunity for members of the public to file a request for hearing and/or petition to intervene.

#### Oconee 1, 2, and 3 Measurement Uncertainty Recapture (MUR) Power Uprate Acceptance

By application dated September 20, 2011, the licensee requested a 1.6 percent MUR power uprate for Oconee Units 1, 2, and 3, using Cameron CheckPlus Leading Edge Flow Meter ultrasonic flow measurement instrumentation. On November 7, 2011, the NRC identified the need for supplemental information and by letter dated November 21, 2011, the licensee provided the supplemental information. By letter dated December 8, 2011, NRC informed the licensee that the application provides technical information in sufficient detail to enable the staff to proceed with its detailed technical review.
