NRC Enforcement Policy; Policy Revision; Issuance and Request for Comments (NRC-2013-0014)

On January 28, 2013, the NRC published a notice in the *Federal Register* (78 FR 5838) issuing a revision to its Enforcement Policy that incorporated changes made by the Commission, made other changes proposed and evaluated by the staff, and made other minor edits. The revision was effective on January 28, 2013. The notice also requested comments on the Enforcement Policy revision that will be considered by the NRC before the next Enforcement Policy revision. Public comments are due by February 27, 2013.

NRC Child Care Subsidy Program

On January 30, 2013, as a result of full and open solicitation for total small business set aside, a firm-fixed price contract (NRC-HQ-13-C-38-0020) was awarded to FEEA Childcare Services, Inc. of Lakewood, CO. The contractor will administer NRC's Childcare Subsidy Program. The period of performance is February 1, 2013, to January 31, 2014, with four 1-year option periods. The total estimated cost of this contract is \$281,458.44, inclusive of all options.

NRC Outreach and Recruitment Events Management Program

On January 31, 2013, as a result of an 8(a) non-competitive solicitation, an indefinite delivery/indefinite quantity contract (NRC-HQ-13-C-38-0019) was awarded to Projectworks, LLC, of Frederick, MD. The contractor will provide NRC with outreach and recruitment events management. The period of performance is from February 1, 2013, to January 31, 2014, with four 1-year option periods. The total estimated cost of this contract is \$807,234.12, inclusive of all options.

Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending February 1, 2013

<u>Changes in Decommissioning Waste Disposal Costs at Low-Level Waste Burial Facilities</u> (Final Report)

On January 23, 2013, the staff published NUREG-1307, Revision 15, "Report on Waste Burial Charges – Changes in Decommissioning Waste Disposal Costs at Low-Level Waste Burial Facilities (Final Report)," (ADAMS Accession No. ML13023A030). NUREG-1307 is updated every two years for use by licensees for their decommissioning funding reports. Per NRC requirements under 10 CFR 50.75, licensees must estimate the cost of decommissioning their facilities to ensure that adequate funds are available when needed for safe decommissioning and report those estimates to the NRC every two years. The factors for labor and energy are to be taken from regional data of the U.S. Department of Labor Bureau of Labor Statistics, and the burial factor is to be taken from NUREG-1307. The next due date for submittal of the licensees' decommissioning funding status reports is March 31, 2013.

<u>Publication of Draft Regulatory Guide DG-1300, "Quality Assurance Program Requirements</u> (Operations)"

On January 25, 2013, the staff announced the release of Draft Regulatory Guide (DG)-1300, "Quality Assurance Program Requirements (Operations)," to provide the public an opportunity to comment on this proposed Revision 3 of Regulatory Guide (RG) 1.33. Revision 3 endorses ANSI/ANS 3.2-2012, "Managerial, Administrative, and Quality Assurance Controls for Operational Phase of Nuclear Power Plants," which is an update to the standard that was endorsed in Revision 2, ANS 3.2/ANSI N18.7-1976, "Administrative Controls and Quality Assurance for the Operational Phase of Nuclear Power Plants." The updated standard incorporates operational experience since the original standard was developed, and is better focused on quality assurance of plant operations because information on quality assurance of design and construction was moved to the American Society of Mechanical Engineers standard Nuclear Quality Assurance-1 (NQA-1), "Quality Assurance Program Requirements for Nuclear Power Plants." Draft regulatory guide DG-1300 is available in ADAMS at ML12276A071.
