Piping Integrity Analyses II

On May 15, 2013, as a result of a competitive U.S. General Services Administration Federal Supply Schedule solicitation, the NRC awarded a Labor Hour/Time and Materials delivery order (NRC-HQ-13-F-04-0001) to Battelle Memorial Institute of Columbus, OH. This delivery order will provide professional engineering services in support of the Office of Nuclear Regulatory Research's "Piping Integrity Analyses II" requirement. The period of performance is from May 15, 2013, to May 14, 2015. The total value of the contract is \$807,186.

Revisions to Transportation Safety Requirements and Harmonization with International Atomic Energy Agency Transportation Requirements; Establishing Quality Assurance Programs for Packaging Used in Transport of Radioactive Material; Proposed Rule; 10 CFR Part 71 (RIN 3150-AI11; NRC-2008-0198; NRC-2013-0082)

On May 16, 2013, the NRC, in consultation with the U.S. Department of Transportation (DOT), published a proposed rule in the *Federal Register* (78 FR 28988) that proposes to amend its regulations for the packaging and transportation of radioactive material. The amendments would make the NRC's regulations conform to revisions to the International Atomic Energy Agency's regulations for the international transportation of radioactive material and maintain consistency with DOT regulations. The parallel DOT proposed rulemaking was published in the *Federal Register* on August 12, 2011, (76 FR 50332). The comment period on the proposed rule closes on July 30, 2013, and the comment period on the information collections aspect of the proposed rule closes on June 17, 2013. In the same issue of the *Federal Register*, the NRC published a document (78 FR 29016) requesting public comment on draft regulatory guide DG-7009, "Establishing Quality Assurance Programs for Packaging Used in Transport of Radioactive Material." This draft regulatory guide describes a proposed method that the NRC staff considers acceptable for use in complying with the aforementioned proposed rule. The comment period on DG-7009 closes on July 30, 2013.

Annual Meeting on Reactor Operator Qualification and Training

On May 8, 2013, the staff met with the Vice President, Training and Accreditation, Institute of Nuclear Power Operations (INPO), and members of his staff for the annual public meeting on training and qualification. The purpose of the coordination meeting was to discuss INPO and NRC initiatives and issues related to the training and qualification of nuclear power plant personnel. Topics discussed included new reactor accreditation, training issues related to recommendation eight of the Fukushima Near Term Task Force, the licensed operator requalification inspection procedure, the National Academy for Nuclear Training electronic learning system, INPO's efforts to improve operator fundamentals, and leadership development initiatives. No new policy issues were identified during the meeting.
