Retirement Counseling Services

On February 19, 2014, as a result of a competitive GSA Schedule solicitation, a labor hour contract (NRC-HQ-84-14-C-0001) was awarded to TAI Pedro & Associates P.C., of Silver Spring, MD. This contract will provide retirement counseling services to U.S. Nuclear Regulatory Commission (NRC) employees. The period of performance is from March 12, 2014 to March 11, 2015, with four 1-year option periods. The total value of this contract is \$399,891.02, inclusive of all options.

Retrospective Analysis under Executive Order 13579: Final Plan for Retrospective Analysis of Existing Rules; 2 CFR Chapter XX, 5 CFR Chapter XLVIII, and 10 CFR Chapter I (NRC-2011-0246)

On February 24, 2014, the NRC published a document in the *Federal Register* (79 FR 9981) making available its final Plan for the retrospective analysis of its existing rules. The final Plan describes the processes and activities that the NRC uses to determine whether any of its regulations should be modified, streamlined, expanded, or repealed. This action is part of the NRC's voluntary implementation of Executive Order 13579, "Regulation and Independent Regulatory Agencies," issued by the President on July 11, 2011. The final Plan was effective on February 24, 2014.

Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending February 28, 2014

Issuance of Davis-Besse Draft Supplemental Environmental Impact Statement

On February 26, 2014, the staff issued for public comment the draft supplemental environmental impact statement (SEIS) on the proposed renewal of the operating license for Davis-Besse Nuclear Power Station, Unit 1. The report contains the NRC's preliminary finding that there are no environmental impacts that would preclude the option of license renewal for an additional 20 years of operation. As part of the environmental review of the application, the NRC will hold public meetings on March 25, 2014, near the plant, to discuss the preliminary findings in the draft SEIS and to solicit public comments on the document. The public comment period ends April 21, 2014. This is the fifth license renewal environmental impact statement issued since the United States Court of Appeals for the District of Columbia Circuit vacated the Waste Confidence Decision rule. The staff continues to move forward with license renewal reviews; however, consistent with the direction provided by the Commission, the staff will not issue renewed licenses until the issues related to waste confidence are appropriately addressed.
