Audit of Defense Nuclear Facilities Safety Board's Annual Financial Statement

On July 1, 2014, as a result of a competitive General Services Administration Federal Supply Schedule task order solicitation, Contract No. GS23F0168N, Task Order No. NRC-HQ-30-14-T-0001 was awarded on a labor-hour basis to Acuity Consulting Incorporated, a small business in Alexandria, Virginia. This task order will procure financial auditing services for Defense Nuclear Facilities Safety Board's annual financial statements. The period of performance is July 1, 2014 through June 30, 2017, with two 1-year option periods. The total task order value is \$184,571.42, inclusive of options.

Systematic Human Performance Data Collection

On July 1, 2014, as a result of a task order under existing umbrella contract, a cost reimbursement (NRC-HQ-12-C-04-0058, Task: NRC-HQ-60-14-T-0001) was awarded to University of Central Florida (UCF), in Orlando, Florida.
