List of Approved Spent Fuel Storage Casks: Holtec International HI–STORM
FLOOD/WIND System; Certificate of Compliance (CoC) No. 1032, Amendment No. 1:
Direct Final Rule; 10 Code of Federal Regulations (CFR) Part 72 (Regulation Identifier Number 3150-AJ40; NRC-2014-0102)

On October 3, 2014, the NRC published a document in the *Federal Register* (79 FR 59623) amending its spent fuel storage regulations by revising the Holtec International HI-STORM FLOOD/WIND System listing within the "List of approved spent fuel storage casks," to include Amendment No. 1 to CoC No. 1032. Amendment No. 1 adds a new heat load pattern for the multipurpose canister (MPC)-37, broadens the back pressure range for MPC-37 and MPC-89, and updates certain definitions related to fuel classification. Also, the amendment makes a correction to the expiration date of CoC No. 1032. The companion proposed rule was also published in the *Federal Register* on October 3, 2014 (79 FR 59693). This direct final rule is effective December 17, 2014, unless significant adverse comments are received by November 3, 2014.

### <u>Fuel-Cladding Issues in Postulated Spent Fuel Pool Accidents: Petition for Rulemaking (PRM); Notice of Docketing; 10 CFR Part 50 (PRM-50-108; NRC-2014-171)</u>

On October 7, 2014, the NRC published a notice of docketing in the *Federal Register* (79 FR 60383) of a petition for rulemaking (PRM) from Mr. Mark Edward Leyse (the petitioner), dated June 19, 2014. The petition was docketed by the NRC on July 14, 2014, and has been assigned Docket No. PRM-50-108. The petitioner requests that the NRC make new regulations concerning the use of spent fuel pool accident evaluation models. The NRC is not requesting public comment on PRM-50-108 at this time.
