MS. VIETTI-COOK: The Commission is being asked to act on a final rule amending 10 CFR Part 2 to substantially modify the NRC's regulations governing the conduct of hearings. The Commission has voted to approve the publication and implementation of this final rule subject to the comments and changes provided in the attachment. Would you please affirm your votes?

MS. VIETTI-COOK: The second item is on Sequoyah Fuels Corporation. The Commission has voted to approve a Memorandum and Order which answers the Presiding Officer's certified question and states that Sequoyah Fuels Corporation's frontend waste can be considered as Atomic Energy Act section 11e(2) byproduct material and remands this matter to the Presiding Officer for action consistent with this decision. Would you please affirm your votes?
