CHAIRMAN JACZKO: Madam Secretary, we have one item for affirmation today.

MS. VIETTI-COOK: This is on the U.S. Department of Energy's High Level Waste Repository. The Commission is being asked to act on a Memorandum and Order responding to appeals by Clark County, Nevada, and the NRC Staff of the First Prehearing Conference Order issued by the three Construction Authorization Boards in this proceeding. The Commission has voted to approve a Memorandum and Order which affirms in part and reverses in part the appealed contention admissibility rulings of the Construction Authorization Boards. Would you please affirm your votes?

COMMISSIONER LYONS: Aye.

COMMISSIONER KLEIN: Aye.

COMMISSIONER SVINICKI: Aye.

MS. VIETTI-COOK. That's all I have. Thank you.

CHAIRMAN JACZKO: Well thanks. I had just two quick comments I wanted to make. One, I wanted to thank the contingent of staff, sitting to our left, who worked very hard to put together and complete this action today to keep the Commission on its schedule, which is an extremely aggressive schedule for dealing with this particular matter, and I think it certainly is a testament to their work, the work of the Licensing Boards to have done the first order which we are responding to to complete that all in a timely manner. I think I certainly want to express my appreciation to them. The second thing I want to say, this is our last opportunity to embarrass Commissioner Lyons. So I want to just take a few moments. I know we don't have a large number of people here in attendance, but this will be recorded with the official transcript and I think I just want to again express my appreciation for the work that he's done as we've served together for nearly four and half years. We came together to the Commission, as he reminded me yesterday, four days apart, and I have certainly personally appreciated my opportunity to work with him. And when he came I would like to say we were colleagues and as he leaves I'd like say that that we're friends. And that's something that I think I will certainly miss his presence here and I think the Agency is a better place now than it was when he came and I know the staff certainly appreciates his time here and I just wanted to say thanks for all your hard work and good luck with your future endeavors.

COMMISSIONER LYONS: Thank you.

CHAIRMAN JACZKO: Any other Commissioners have any comments?

COMMISSIONER KLEIN: I'd like to also add my thanks for Pete's long public service, not only at the NRC but with Senator Domenici for all those years and also for Los Alamos, and I don't think this will be the last chance we have to embarrass Commissioner Lyons. I think we'll probably see him in energy areas for the future and his fifth career, whatever it may be, but it's been a pleasure. I've worked with Pete for a number of years and I've enjoyed all of them, including the last about three years here at the NRC.

COMMISSIONER SVINICKI: And I'd certainly like to join in and say that I've had a couple of different capacities where I've been very honored to call Pete my colleague and my friend and this is just the latest iteration, but it's been wonderful to serve along side you. Thank you for all the assistance that you provided me over the course of the last year, Pete, and I look forward to working with you in the future. Thank you.
