CHAIRMAN JACZKO: We will begin with three items for affirmation.

MS. VIETTI-COOK: Yes we have three items for affirmation. The first two items are on Entergy Nuclear Generation Co. and Entergy Nuclear Operations, (Pilgrim Nuclear Power Station). The Commission is being asked to act on a Memorandum and Order responding to intervenor Pilgrim Watch's petition for review of several Atomic Safety and Licensing Board decisions in this license renewal proceeding. On March 26, 2010, the Commission issued CLI-10-11, addressing Pilgrim Watch's challenge to LBP-07-13. Remaining are Pilgrim Watch's challenges to LBP-08-22, LBP-06-23, LBP-07-12, and several unpublished Board orders. The Commission, with Chairman Jaczko disapproving in part, has voted to approve a Memorandum and Order, which denies the balance of the petition for review. Commissioner Apostolakis did not participate in this matter. Would Chairman Jaczko and Commissioners Svinicki, Magwood, and Ostendorff please affirm your votes?

Commissioner Apostolakis did not participate in this matter. Would Chairman Jaczko and Commissioners Svinicki, Magwood and Ostendorff please affirm your votes?

MS. VIETTI-COOK. In the last item South Texas Project Nuclear Operating Co. (South Texas Project Units 3 and 4). The Commission is being asked to act on a Memorandum and Order responding to a joint appeal filed by the Sustainable Energy and Economic Development Coalition, the South Texas Association for Responsible Energy, and Public Citizen of the Atomic Safety and Licensing Board's ruling in LBP-10-2, declining to admit Contentions MS-1, MS-3, and MS-6. The Commission has voted to approve a Memorandum and Order which denies the appeal as premature, without prejudice to the Intervenors' ability to petition for review of the contention admissibility decision at the end of the case. Commissioner Magwood did not participate in this matter. Would Chairman Jaczko and Commissioners Svinicki, Apostolakis and Ostendorff please affirm your votes?
