PROCEEDINGS

CHAIRMAN JACZKO: We will begin with affirmation items.

MS. VIETTI-COOK: The first item is SECY-10-0030 Entergy Nuclear Vermont Yankee and Entergy Nuclear Operations (Vermont Yankee Nuclear Power Station). The Commission is being asked to act on a Memorandum and Order responding to two petitions for review. The NRC Staff seeks review of Atomic Safety and Licensing Board's Partial Initial Decision in LBP-08-25. The New England Coalition seeks review of the Board's later decision in LBP-09-9. The Commission has voted to approve a Memorandum and Order which reverses those portions of LBP-08-25 addressing Contentions 2A and 2B related to the calculation of the environmentally adjusted cumulative usage factor for the core spray and reactor recirculation outlet nozzle. The Memorandum and Order considers the substance of the New England Coalition's arguments regarding Contention 2C and finds them to be without merit, but grants the New England Coalition the opportunity to resubmit its original Contention 2 or submit a revised version of that contention. The Memorandum and Order also grants the non-litigant's motion for leave to file a *amici curiae brief*. Commissioner Apostolakis did not participate in this matter. Would Chairman Jaczko and Commissioners Svinicki, Magwood, and Ostendorff please affirm your votes?

The Commission is being asked to act on a Memorandum and Order responding to Petitions for Review filed by Pa'ina Hawaii and the NRC staff of the Atomic Safety and Licensing Board's final initial decision. The Commission has voted to approve a Memorandum and Order which takes review of the Board's decision, admits Amended Contention 3 and remands it to the Board for further consideration, affirms the Board's rulings in connection with Contention 4, affirms the Board's determination to require an additional written comment period on the staff's amended Environmental Assessment, and denies Pa'ina's request to reinstate the categorical exclusion associated with its proposed irradiator. Would please affirm your votes?

The Commission is being asked to act on a Memorandum and Order responding to a question certified by the Atomic Safety and Licensing Board in this license renewal proceeding, seeking Commission clarification on how to respond to a motion by intervenor Hudson River Sloop Clearwater to submit two new contentions, related to the continued viability of the Waste Confidence Rule. The Commission has voted to approve a Memorandum and Order which directs the Board to deny admission of Clearwater's contentions as improper challenges to the ongoing waste confidence rulemaking. Commissioner Apostolakis did not participate in this matter. Would Chairman Jaczko and Commissioners Svinicki, Magwood and Ostendorff please affirm your votes?
