PROCEEDINGS

CHAIRMAN JACZKO: We have two items for affirmation. Are you ready to go through them?

MR. BATES: Commissioner Magwood, you're on the line?

COMMISSIONER MAGWOOD: Yes, I am.

MR. BATES: The first item we have today is in the matter of the Luminant Generation Company LLC in the Comanche Peak Nuclear Power Plant Units 3 and 4, Energy Northwest Columbia Generating Station, Southern Nuclear Operating Company, Vogtle Units 3 and 4, Duke Energy Carolinas LLC, William States Lee III Nuclear Station Units 1 and 2. The Commission is being asked to act on a Memorandum and Order responding to four substantively identical petitions for review of LBP-11-27, a Board decision declining to admit a NEPA contention arising from the report of the Fukushima Near-Term Task Force. The Commission has voted to approve a Memorandum and Order, as we circulated, which denies the petitions for review. Commissioner Magwood's approval did not pertain to the *Comanche Peak* COL proceeding, in which he is not participating. Will you please affirm your votes?

CHAIRMAN JACZKO: Aye.

COMMISSIONER SVINICKI: Aye.

COMMISSIONER APOSTOLAKIS: Aye.

COMMISSIONER OSTENDORFF: Aye.

MR. BATES: Commissioner Magwood?

COMMISSIONER MAGWOOD: Aye.

MR. BATES: The second item is SECY-11-0170. It's a final rule on physical protection of byproduct material. The Commission is being asked to act on a Final Rule that adds a new Part 37 to Title 10 of the Code of Federal Regulations and making conforming changes to Parts

20, 30, 32, 33, 34, 35, 36, 39, 51, 71, and 73. The rule amends the regulations to establish security requirements for the use of Category I and Category II quantities of radioactive material and for the transportation of small quantities of irradiated fuel. The Commission has approved the publication and implementation of this final rule subject to changes that we circulated. Will you approve your votes please?

COMMISSIONER SVINICKI: Aye.

COMMISSIONER APOSTOLAKIS: Aye.

COMMISSIONER OSTENDORFF: Aye.

MR. BATES: Commissioner Magwood?

COMMISSIONER MAGWOOD: Aye.

CHAIRMAN JACZKO: I would note for the record that Josie Piccone gave this two thumbs up and this is a very significant rule and we'll make sure we do our press release on Monday. Or do you want to do it today? Congratulations, this is a significant milestone. I appreciate everybody's hard work on that and getting it done. It's a really good rule and a lot of good effort went into it. So, thank you. We are adjourned.
