Block 2: Title and Subtitle

State the complete title and subtitles as you want them to appear on the cover and title page, following the U. S. Government Publishing Office Style Manual 2008 Capitalization Rules. Make them concise, and do not include such words as "report" or "publication" in the title.

Block 3: Distribution
